

H. No. 3014 - An Act providing for the establishment of a Pilot Experimental Free School Lunch Project for School Children in the Pasil Elementary School, Indanan, Sulu, and authorizing the appropriation of the necessary funds therefor.

Introduced by the Committee on Education and the Committee on Appropriation as per Committee Report No. 1766;

Submitted to the Senate on May 17, 1962;

Referred to the Committee on Education on the same day;

Returned by said Committee with the Committee Report No. 592, recommending that it be approved without amendment on May 9, 1963;

Submitted said Report to the Senate on May 10, 1963;

Passed on second reading by the Senate without amendment on May 16, 1963;

Printed copies distributed to the Senators on the same day;

Passed on third reading without amendment by the Senate on May 22, 1963;

Vetoed by the President of the Philippines on June 22, 1963;

H. No. 3015 - An Act amending Sections two and three of Republic Act Numbered Two thousand three hundred thirty-four, entitled "An Act Providing For The Rotation Of Reserve Officers Of The Armed Forces Of The Philippines In The Active Military Service.

Introduced by Congressmen Ligot, Lucman, Ferrer, Bagatsing, Balite, Crisologo, Raquiza etc.;

Submitted to the Senate on May 16, 1962;

Referred to the Committee on National Defense and Security on the same day;

Returned by said Committee with the Committee Report No. 302, recommending that it be approved without amendment on May 17, 1962;

Submitted said Report to the Senate on the same day;

Amended Com. Rept. No. 481 was filed on May 6, 1963, recommending that H. No. 3015 and S. No. 304 be consolidated and the House Bill

be approved with amendment on May 6, 1963;

Submitted to the Senate on May 7, 1963;

H. No. 3018 - An Act to amend certain Sections of Republic Act Numbered Twenty-three hundred and eighty-two, otherwise known as "The Medical Act of 1959."

Introduced by the Committee on Health as per Com. Rept. No. 1770;

Submitted to the Senate on May 15, 1963;

Referred to the Committee on Health on the same day;

Returned by said Committee with the Committee Report No. 963, recommending that it be approved without amendment on May 23, 1963;

Submitted said Report to the Senate on the same day;

Amended C. R. No. 1231 was filed on May 5, 1964, recommending that it be approved with amendments;

- Submitted said Report to the Senate on the same day;
- Passed on second reading by the Senate with amendments on May 15, 1964;
- Printed copies distributed to the Senators on February 26, 1965;
- Approval of second reading was reconsidered on May 14, 1965 and reapproved with amendment on the same day;
- Passed on third reading with amendments by the Senate on May 18, 1965;
- Amendments of the Senate sent to the House on May 19, 1965;
- The House agreed to the amendments of the Senate on May 20, 1965;
- Approved by the President of the Philippines on June 19, 1965;
- Converted into Republic Act No. 4224.

- H. No. 3020 - An Act to further amend Section twenty hundred sixty-seven-B of the Administrative Code, and the respective City Charters, except the Cities of Manila and Trece Martires, as amended by Republic Act Numbered Eight hundred forty, fixing the salaries of Provincial and City Officials.
- Introduced by Congressmen Ferrer, Josen, Veloso (F.), Briones, Ligot, Macias, Ubay and others;
  - Submitted to the Senate on May 7, 1963;
  - Referred to the Committee on Provincial and Municipal Governments and Cities on the same day;
  - Returned by said Committee with the Committee Report No. 692, recommending that S. 192 and H-3020 be consolidated and that the attached amendment by substitution to H. No. 3020 be approved without amendment on May 13, 1963;
  - Submitted said Report to the Senate on May 14, 1963;
  - Passed on second reading by the Senate with amendment on May 15, 1963;
  - Printed copies distributed to the Senators on May 17, 1963;
  - Certified for immediate enactment by the President of the Philippines on May 7, 1963;
  - Passed on third reading with amendments by the Senate on May 20, 1963;
  - Amendments of the Senate sent to the House on the same day;
  - The House disagreed to the amendments of the Senate, and asked for a conference on May 20, 1963, having designated as representatives on its part Congressmen Ubay, Josen, and Agbayani;
  - The Senate insisted on its amendments, and accepted the conference asked for by the House on May 21, 1963, having appointed as conferees at the same on its part Senators Padilla, Manahan and Ledesma;
  - Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on May 22, 1963;
  - The House approved the Report of the Conference Committee on May 22, 1963;
