The Committee on Health to which was referred H. No. 3018, 5th C. R. P., introduced by the Committee on Health as Per Committee Report No. 1770, entitled:

AN ACT TO AMEND CERTAIN SECTIONS OF REPUBLIC ACT NUMBERED TWENTY-THREE HUNDRED AND EIGHTY-TWO, OTHERWISE KNOWN AS "THE MEDICAL ACT OF 1959,"

has considered the same and has the honor to report it back to the Senate with the following recommendation:

THAT IT BE APPROVED WITH THE FOLLOWING AMENDMENTS:

On page 13, line 23, after the comma (,) add the words WITHOUT NAMES

On page 14, line 1, after the word "SHALL" add the phrase INSERT THE NAMES AND

On page 14, line 14, before the word "BY", delete the word TO and between the comma (,) and the word "is" put (5).

On page 15, line 1, delete the phrase "TERM OF THREE YEARS WITHOUT REAPPOINTMENT AND" and in lieu thereof put the following: TERM OF THREE YEARS AND MAY BE REAPPOINTED AND

On page 17, line 8, delete the word "He" before the word "shall" and in lieu thereof place the words THE SECRETARY.

On page 17, lines 13 and 14, between the words "physician" and "in", delete the words "one in May and one in November every" and in lieu thereof, insert TWICE A YEAR ON DATES TO BE DETERMINED BY IT PROVIDED THAT THE INTERVAL BETWEEN THE FIRST AND THE SECOND EXAMINATIONS IN A YEAR SHALL BE SIX MONTHS.

On page 17, line 22, after the word "complete" delete the word "physical" and in lieu thereof place the word PHYSICIAN.

On page 18, line 12, between the period (.) and the word "shall" delete the word "The" and in lieu thereof place the word THEY.

On page 18, line 22, after the word "THE" and "EXAMINATION" delete the word FOLLOWING.

On page 21, line 4, after the period (.) add PROVIDED THAT A CANDIDATE WHO FAILS FOR THE THIRD TIME IN THE COMPLETE OR FINAL EXAMINATIONS WILL BE REQUIRED TO TAKE A REFRESHER COURSE PRESCRIBED BY THE BOARD OF MEDICAL EXAMINERS OF AT LEAST ONE (1) YEAR IN A RECOGNIZED MEDICAL SCHOOL OR COLLEGE BEFORE HE COULD BE ALLOWED TO TAKE SUBSEQUENT EXAMINATIONS.
