AN ACT
PROVIDING FOR A 30-YEAR NATIONAL INFRASTRUCTURE PROGRAM

EXPLANATORY NOTE

A safe, efficient, and accessible national infrastructure backbone is vital to foster the sustainable and inclusive socio-economic development of the present and future generations of Filipinos. This national infrastructure system should help realize the long-term vision for the Philippines under *Ambisyon Natin 2040*, by the middle of this century, as a progressive, mainly middle-class society, where nobody is poor, where the citizens enjoy healthy lives, are smart and innovative, and live in a high-trust community.

Major infrastructure facilities are generally capital-intensive, thus, their preparation and implementation take several years, in order to adopt an overall long-term development program for national infrastructure, and better rationalize the traditional medium-term and annual programs. This long-term program should cover at least 30 years. This will ensure continuity in the development and implementation of the projects in the program, notwithstanding changes in national leadership. The Program will provide the guiding framework for the appropriate locations, scales, linkages, and schedules of public and private investments in major infrastructure in the country over the next three decades in order to maximize their benefits to the economy. This will, thus, serve as a predictable road map for the construction industry, investors, and related business sectors in carrying out their long-term plans and decisions.

The adverse effects of the COVID-19 pandemic, coupled with the recent spate of destructive typhoons and floods that struck the country, further highlight the need for longer-range, resilient, and high-impact engineering projects that will more effectively address major disruptive events, while complementing immediate emergency responses.

Finally, it is necessary to institutionalize, beyond the next six years and over at least the next three decades, the "Build Better More" plan of the current administration, so as to accelerate and sustain in a seamless manner the provision of a strong, safe, dependable, and cost-effective national infrastructure system that will support robust economic development, generate jobs, and improve the quality of life of Filipinos throughout the country.

Given the foregoing premises, this bill, therefore, adopts a 30-Year National Infrastructure Program for the Philippines. The Program covers major infrastructure projects of the National Government (NG) - in the fields of transport and logistics, energy, water resources, information and communications technology, social, and agri-fisheries modernization and food logistics infrastructure - including projects under Public-Private Partnership (PPP) schemes and partnerships with Local Government Units (LGUs).

The National Economic and Development Authority (NEDA), in coordination with the Oversight and Implementing Agencies, shall be responsible for formulating the details of the 30-Year National Infrastructure Program, divided into Medium-Term Programs, including the component projects with their descriptions, scopes, estimated costs, funding requirements, schedules, financing and implementation modalities, and Implementing Agencies. The NEDA shall review and update the 30-Year National Infrastructure Program at the end of each Medium-Term Program.

From the 30-Year Program, the Agencies shall formulate their Medium-Term Infrastructure Programs and Annual Infrastructure Budgets (AIBs) to be integrated into the National Expenditure Programs (NEPs) for submission to the Congress as basis of the General Appropriations Acts (GAAs).

This bill has been previously filed by Sen. Emmanuel D. Pacquiao in the 18th Congress.

In view of the foregoing, the approval of this measure is earnestly sought.

AN ACT
PROVIDING FOR A 30-YEAR NATIONAL INFRASTRUCTURE PROGRAM

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 Section 1. *Short Title.* - This Act shall be known as "*The 30-Year National*
2 *Infrastructure Program Act of 2022.*"

3 Sec. 2. *Declaration of Policy.* - It is the policy of the State to provide an efficient
4 infrastructure system to promote sustainable and inclusive economic growth and sound
5 quality of life for all Filipinos. For this purpose, the Government shall provide for a long-
6 term National Infrastructure Program covering the next thirty (30) years for the
7 systematic and continuing development of essential transport and logistics, energy,
8 water resources, information and communications technology, social, agri-fisheries
9 modernization and food logistics infrastructure systems, and other basic overhead
10 facilities in the country.

11 This Infrastructure Program shall be directed to support the achievement of the
12 overall long-term development vision for the Philippines, by the middle of this century,
13 as a prosperous, predominantly middle-class society, where no one is poor, and
14 Filipinos shall live long and healthy lives, be smart and innovative, and live in a high-
15 trust society. The Program shall serve as the overall guide for the preferred locations,
16 magnitudes, interrelationships, and timing of public and private investments in
17 infrastructure in the Philippines over the next three decades to maximize their impact
18 to the economy and society. The Program shall, therefore, provide an overall road map

1 for the construction industry, investors, and allied sectors in pursuing their long-term
2 strategies.

3 *Sec. 3. Definition of Terms.* – The following terms as used in this Act are defined
4 as indicated:

- 5 a. *Agri-fisheries Modernization and Food Logistics Infrastructure* – refers to
6 facilities which include farm access roads, trading posts, agricultural tramlines
7 and other market infrastructure, fish ports, irrigation and soil and water
8 conservation structures, post-harvest facilities such as warehouses, cold
9 storage, meat establishment infrastructure such as slaughterhouses, and
10 production infrastructure such as greenhouses, hydroponics, aquaponics, and
11 food irradiation facilities. This includes the health and safety infrastructure
12 required to meet regulatory standards;
- 13 b. *Blended Financing* - refers to the strategic use of combined concessional funds
14 from development institutions or partners and commercial funds from lenders
15 and private investors to provide financing for Public-Private Partnership (PPP)
16 projects;
- 17 c. *Co-financing* - refers to collaborative financing of a project by two or more banks
18 or financing institutions;
- 19 d. *Core Infrastructure Projects* – refer to projects in the 30-Year National
20 Infrastructure Program with the highest priority in terms of national significance
21 and impact;
- 22 e. *Energy Infrastructure* – refers to infrastructure for power generation,
23 transmission, and distribution, and electrification, as well as for exploration,
24 development, production, storage and distribution of energy resources including
25 those using water resources, fossil fuel, geothermal, solar, wind, wave, and
26 other emerging technologies;
- 27 f. *Green Financing* - refers to investments that create environmental benefits in
28 support of green growth, low-carbon emission, and sustainable development;
- 29 g. *Implementing Agencies* – refer to the National Government Agencies responsible
30 for the actual execution of specific infrastructure projects in the 30-year
31 program, including the planning, design, programming, budgeting,

1 procurement, and implementation of the projects, in accordance with the
2 provisions of this Act;

3 h. *Information and Communications Technology (ICT) Infrastructure* – refers to
4 facilities that provide access to information through telecommunications,
5 including the internet, wireless networks, telephone systems, and other digital
6 technologies and communication media;

7 i. *Infrastructure* – refers to the basic physical facility, for use by the public, that
8 underlie and enable, sustain, and enhance the economic and social development
9 of the country. Infrastructure includes transport and logistics, energy, water
10 resources, information and communications technology, social, agri-fisheries
11 modernization and food logistics infrastructure systems, and other basic
12 overhead facilities;

13 j. *Oversight Agencies* – refer to the National Government Agencies, particularly,
14 the National Economic and Development Authority (NEDA), Department of
15 Budget and Management (DBM), and Department of Finance (DOF), responsible
16 for providing policy and operational guidelines to, and monitoring the
17 compliance thereof, by the implementing agencies, pertaining to the planning,
18 programming, budgeting, procurement, and implementation of infrastructure
19 projects, in accordance with the provisions of this Act;

20 k. *Projects of National Significance* - refer to infrastructure projects whose socio-
21 economic influence or impact significantly affect the entire country based on
22 specific guidelines and criteria to be set by the NEDA;

23 l. *Social Infrastructure* – refers to school buildings, hospitals and health facilities,
24 public housing, solid waste management, penitentiary, evacuation centers, and
25 other public and community facilities. The term also includes, as an important
26 sub-sector, waste management and circular economy infrastructure, which
27 refers to infrastructure for solid waste collection, distribution, and disposal,
28 waste aggregation and transfer stations, waste markets, material recycling,
29 sustainable production, material recovery, and waste-to-energy facilities;

30 m. *Transport and Logistics Infrastructure* – refers to (i) roads, bridges, tunnels,
31 grade separation, and related structures; (ii) rail, bus rapid transit and other
32 mass transport systems, including subways, fixed facilities, and rolling stock; (iii)

1 ports, including terminals and navigation facilities; (iv) airports, including
2 terminals and navigation facilities; (v) intermodal transport facilities, including
3 terminals; and (vi) supply chain infrastructure, including warehouses and
4 distribution centers. Transport infrastructure includes support systems for the
5 operation of transport services and facilities, such as intelligent transport
6 systems;

- 7 n. *Water Resources Infrastructure* – refers to (i) water supply, sewerage, and
8 sanitation for domestic, commercial and industrial uses; (ii) irrigation for
9 agriculture; and (iii) flood control and drainage facilities, including dams,
10 reservoirs, and coastal zone protection.

11 *Sec. 4. Creation of the 30-Year National Infrastructure Program.* - There is hereby
12 provided a 30-Year National Infrastructure Program for the Philippines for the Years
13 2023-2052, hereinafter referred to as the Program. This Program consists of major
14 infrastructure projects of the National Government to be implemented under any of the
15 following modes: (a) by the concerned National Government Agencies and
16 Government-Owned and Controlled Corporations, as provided under their respective
17 charters; (b) under PPP arrangements; or (c) in partnership with Local Government
18 Units (LGUs).

19 *Sec. 5. Infrastructure Policies and Strategies.* - The Program, through its
20 component projects, shall pursue the following national development policies and
21 strategies of the Government:

- 22 a. Prioritization of projects of national significance, which are consistent with the
23 approved National Physical Framework Plan and Land Use Plan, as well as with
24 National, Regional, Local, and Sectoral Development Plans, Roadmaps, and
25 Master Plans;
- 26 b. Observance of the following principles in the determination of priorities:
27 effectiveness in meeting government objectives; economic feasibility and
28 impact; poverty alleviation and social inclusion; environmental sustainability and
29 climate resilience; safety; security; affordability; public access; technical
30 readiness for implementation; and financial viability and value for money;
- 31 c. Maximization of private sector participation in the planning, development,
32 financing, design, construction, operation, and maintenance of infrastructure;

- 1 d. Establishment and pursuit of a whole-of-government strategy to coordinate
2 infrastructure investment planning and implementation that promotes
3 collaboration among key actors, with the NEDA as the lead coordinator;
- 4 e. Promotion of public consultation and feedback mechanisms on infrastructure
5 investment priorities and projects at the national and local levels. These include
6 alliances among the government, affected citizens, industries, investors,
7 academe, think tanks, donor agencies, and other stakeholders to come up with
8 smart approaches to infrastructure development on a sector-by-sector basis;
- 9 f. Implementation of adequate infrastructure asset preservation and maintenance
10 strategies;
- 11 g. Incorporation of green and sustainable design, climate change adaptation and
12 disaster resilience measures, as well as updated strength, safety, health, and
13 environmental standards, in the design and construction of infrastructure
14 projects, especially against powerful and disastrous typhoons, floods,
15 earthquakes, fires, volcanic eruptions, landslides, and other hazards. Utilize
16 nature-based solutions, where appropriate, to promote sustainability and cost-
17 savings. Investment in systems to ensure compliance and enforcement of all
18 safety and construction regulations. Establish a robust national geospatial
19 infrastructure that will provide location-specific spatial data to support evidence-
20 based planning and implementation of infrastructure projects;
- 21 h. Intensification of infrastructure-related research and development;
- 22 i. Deliberate harmonization of technical-vocational and higher education courses
23 offered in educational institutions with the workforce requirements of the long-
24 term infrastructure programs of the government and the private sectors;
- 25 j. Prioritization of the employment of qualified Filipino professional and technical
26 workers in infrastructure projects;
- 27 k. Preferential use of quality construction materials that have a high domestic
28 content, especially those that use sustainable materials and appropriate
29 technology;
- 30 l. Provision of appropriate training of and technology transfer to Filipino
31 counterparts in infrastructure projects involving new or imported technology;

- 1 m. Prioritization of multi-sectoral, multi-modal and area-wide development projects
2 to take advantage of their synergistic effects. Where feasible, provide common
3 underground ducts for utilities, and synchronized timelines for their installation;
- 4 n. Emphasis on food security infrastructure that will ensure the smooth flow of
5 products across the archipelago. This will cover essential transport and logistics,
6 energy, ICT and other agri-fisheries modernization and food logistics
7 infrastructure;
- 8 o. Strict observance of the requirements for technical readiness for
9 implementation, viz., pre-feasibility/feasibility studies, design, right-of-way,
10 environmental clearance, funding, and transaction documents are adequately
11 fulfilled before the procurement and implementation of the projects;
- 12 p. Strict monitoring and project completion of all functional structures;
- 13 q. Requirement for continuity in funding and implementation of multi-year projects
14 up to their completion;
- 15 r. Adoption of appropriate infrastructure risk management measures, including risk
16 identification, allocation, and mitigation, in project development and
17 management. These shall include mechanisms for hindsight review of historical
18 events, as well as foresight strategies, to provide the concerned Agencies and
19 stakeholders the agility to adapt to unpredictable large-impact disruptive events,
20 such as pandemics, severe natural catastrophes, and major financial crises;
- 21 s. Strengthening of the absorptive capacities of the concerned agencies in the
22 implementation of infrastructure projects in order to optimize the utilization of
23 funds; and
- 24 t. Strengthening of transport and other infrastructure to support agriculture,
25 tourism, trade and industry, and electronic commerce, through convergence
26 programs among appropriate national and local government agencies.

27 *Sec. 6. Role of Implementing Agencies in the Development of the Transport and*
28 *Logistics Infrastructure.* - Implementing agencies involved in the development of the
29 Transport and Logistics Infrastructure Program shall pursue the following program
30 directions and responsibilities:

- 31 a. Develop a national transport system with the following characteristics: efficient
32 in facilitating mobility, safe, secure, economical, accessible, affordable,

- 1 environmentally sustainable, user-oriented, reliable, convenient, integrated, and
2 seamless;
- 3 b. Establish a strategic national transport network consisting of complementary
4 roads, rail, ports, and airports that serve medium and long-distance high-density
5 traffic between key cities and municipalities, economic hubs, international
6 gateways, or along major corridors in urban centers. The configuration of the
7 network should fit into and influence the desired spatial development pattern
8 under the National Physical Framework Plan;
- 9 c. Plan and implement transport projects within the context of the entire supply
10 chain and logistics system, facilitative of both traditional and electronic
11 commerce, with a seamless and demand-responsive intermodal transport
12 network, to link production areas with processing, warehousing, transport and
13 transshipment hubs, and markets, and ensure unimpeded flow of people, goods,
14 services, disaster response equipment, relief goods, and basic commodities in
15 times of emergencies;
- 16 d. Focus the role of the government on policy formulation, planning, safety and
17 environmental regulations, supervision, and monitoring of projects and
18 operations, rather than as a direct provider of transport services which shall
19 generally be assigned to the private sector;
- 20 e. Optimize the use of funds through efficient transport infrastructure maintenance
21 and asset management, as well as applicable travel demand management,
22 before considering additional investments;
- 23 f. Make use of the comparative advantages and interconnectivity of the different
24 transport modes, and provide for healthy competition within and between
25 transport modes to increase productivity, lower costs and user charges, and
26 improve services. Allocate resources to the transport modes in accordance with
27 their comparative advantages;
- 28 g. Apply the user-pays principle for cost recovery where it is appropriate;
- 29 h. Improve road-based people-oriented transport to address traffic congestion
30 through engineering, enforcement, and education;

- 1 i. Encourage shift from private to public transport, especially on mass transport,
2 through promotion of active transport culture, cost-effective public transport,
3 and lower and/or zero carbon emissions mobility solutions;
- 4 j. Improve the operational efficiency of airports and address constraints to their
5 optimal capacity utilization; and
- 6 k. Improve port facilities to ensure that inter-island shipping, including a stronger
7 roll-on roll-off (RORO) network, is a viable option for transporting people and
8 cargo.

9 *Sec. 7. Role of Implementing Agencies in the Development of the Energy*
10 *Infrastructure Program.* - Implementing agencies involved in the development of the
11 Energy Infrastructure Program shall pursue the following program directions and
12 responsibilities:

- 13 a. Support the required massive investments and fast track the implementation of
14 infrastructure projects to improve power generation, transmission, and
15 distribution;
- 16 b. Encourage competition to drive down electricity costs;
- 17 c. Pursue development of the natural gas industry, as well as renewable energy
18 such as hydropower, geothermal, wind, and solar and other clean energy
19 technologies as power sources;
- 20 d. Ensure efficient transmission of electricity to various load centers and
21 interconnect the entire grid;
- 22 e. Prioritize the provision of off-grid, stand-alone renewable energy technology to
23 the remaining unelectrified off-grid, island, remote, and last-mile communities;
- 24 f. Implement energy infrastructure projects in accordance with the policies and
25 programs of the Energy Efficiency and Conservation Act of 2019;
- 26 g. Prioritize and fast track the implementation of energy projects of national
27 significance that will ensure energy security and reliability, as well as
28 environmental sustainability aligned with the energy sector's strategic directions,
29 the Government's Nine-Point Energy Agenda, the Philippine Energy Plan and
30 other approved national, regional or local energy plans, among others; and
- 31 h. Promote the deployment of clean, efficient and smart energy technologies, and
32 the establishment of necessary infrastructure and regulatory support.

1 *Sec. 8. Role of the Implementing Agencies involved in the Development of the*
2 *Water Resources Infrastructure Program.* - Implementing agencies involved in the
3 development of the Water Resources Infrastructure Program shall pursue the following
4 program directions and responsibilities:

- 5 a. Create an apex body that will address the fragmented structure of water
6 resources management;
- 7 b. Formulate long-range water resources master plans and multi-purpose projects
8 that will optimize the development and use of water resource potentials for
9 irrigation, power, water supply, and flood control;
- 10 c. Pursue institutional reforms such as streamlining processes in involved agencies
11 to encourage and guide investments in water supply, sewerage, and sanitation;
12 and
- 13 d. Intensify flood control in major river basins, principal rivers, and urban centers,
14 combining structural or engineering intervention works with non-structural
15 measures, such as land use management, watershed conservation, and flood
16 information and warning system, on an area/river system-wide basis, with
17 priority on areas with high risks of flooding.

18 *Sec. 9. Role of the Implementing Agencies involved in the Development of ICT*
19 *Infrastructure Program.* – Implementing Agencies involved in the development of ICT
20 Infrastructure Program shall pursue the following program directions and
21 responsibilities:

- 22 a. Provide digital infrastructure to complement the national broadband plan,
23 geared towards increasing internet access in unserved and underserved areas;
- 24 b. Expand the deployment of ICT infrastructure and address the gaps in digital
25 connectivity and promote digital trade;
- 26 c. Enhance the country's e-government system as a vital tool for good governance,
27 including the improvement and integration of various database and software
28 management systems within and across different sectors and Government
29 bodies. Ensure and improve cybersecurity by investing in robust systems and
30 key management resources;
- 31 d. Use ICT to provide climate-smart and resilient infrastructure, such as flexible
32 smart power grids that can accommodate renewable energy sources, early

1 warning systems for natural hazards, sustainable transport systems that enable
2 public transit, walking, and biking, safety-promoting roadway designs that
3 integrate wastewater management, rainwater harvesting, nature-based
4 solutions to floods, droughts, and typhoons, and green infrastructure in public
5 spaces;

- 6 e. Ensure a fair and level playing field for ICT operators by applying the same
7 service obligations and performance standards;
- 8 f. Fast-track and lower the cost of deploying broadband infrastructure through
9 infrastructure sharing policies that address the use of government assets, use
10 of infrastructure across sectors, and coordinated build for a shared utility
11 corridor;
- 12 g. Avoid direct government investment in network infrastructure and operations
13 that would crowd out private investments in commercially viable areas. Provide
14 necessary infrastructure support to ICT projects, especially in far-flung areas;
- 15 h. Streamline the process for permits for cellular towers, cable laying, and network
16 deployment;
- 17 i. Liberalize access to satellites for internet connectivity to help address digital
18 infrastructure gap in the countryside; and
- 19 j. Prepare for 5G and higher generation technology as a game changer in terms
20 of facilitating digital adoption across sectors.

21 *Sec. 10. Role of the Implementing Agencies involved in the Development of Social*
22 *Infrastructure Program.* - Implementing Agencies involved in the development of
23 Social Infrastructure Program shall pursue the following program directions and
24 responsibilities:

- 25 a. Construct or improve schools with facilities for online or distance learning, as
26 well as blended learning, and provide internet connectivity to all public schools,
27 with the aim of creating Schools for the Future, and schools geared towards
28 competitiveness in the Fourth Industrial Revolution. Give priority to schools for
29 geographically isolated and conflict-affected areas, with provisions for
30 classroom, water, sanitation, and health facilities;
- 31 b. Adopt the Philippine Health Facility Development Plan (PHFDP) as the
32 infrastructure roadmap for hospitals and health facilities towards Universal

- 1 Health Care. Construct and develop modern health facilities that will
2 complement the Universal Health Care Law and national preparedness for
3 surges in demand for pandemics, as well as climate-smart technologies and
4 wellness facilities promoting preventive care against diseases. Pursue the
5 development and expansion of the country's telehealth system to ensure
6 equitable access to healthcare services especially in underserved areas with
7 limited physical access to healthcare professionals;
- 8 c. Construct and improve social housing projects and resettlement areas that
9 adhere to climate change adaptation and disaster risk reduction standards to
10 ensure human, environmental, and ecological safety, as well as access to
11 livelihood opportunities and basic social services, which include communal solar-
12 powered electricity, potable water and drainage, and waste management
13 systems. Identify danger and/or no-build zones to reduce casualties and
14 damages in the event of natural disasters, such as typhoons and earthquakes;
- 15 d. Provide assistance to LGUs in complying with the requirements under the
16 Ecological Solid Waste Management Act, e.g., materials recovery facilities,
17 transfer stations, compost production, and waste-to-energy projects;
- 18 e. Promote proper waste management through public awareness programs and
19 disseminate information on the environmental importance of waste
20 minimization, separation, recycling, reuse, and repurposing;
- 21 f. Encourage public-private cooperation and strategic investments in cutting-edge
22 technologies and facilities to generate economic value and create livelihoods
23 from waste products, including sustainable production using recycled, reused,
24 and repurposed materials;
- 25 g. Advocate the establishment of a national policy for sustainable waste
26 management and roadmap for circular economy development to inform policy
27 and infrastructure pipeline development;
- 28 h. Create an apex body with responsibility for implementing waste management
29 and circular economy policies, plans, programs, and projects, including
30 responsibility to perform the functions outlined in Sections 10-d to 10-g of this
31 Act; and

- 1 i. Construct, improve and renovate prison infrastructure to decongest existing jails
2 and provide humane accommodations, e.g., potable water and proper sanitation
3 facilities, complying with health standards for persons deprived of liberty.

4 Sec. 11. *Role of the Implementing Agencies involved in Agri-Fisheries*
5 *Modernization and Food Logistics.* - Implementing Agencies involved in Agri-Fisheries
6 Modernization and Food Logistics shall pursue the following program directions and
7 responsibilities:

- 8 a. Implement an integrated and long-term agri-fisheries modernization and food
9 logistics infrastructure plan that will accelerate the development and
10 competitiveness of the sector. Implement policies that promote traceability,
11 efficiency, and conservation sufficient to manage resources and attract
12 sustainable investment in the sector; strengthen and coordinate all components
13 of the entire food supply chain and value chain, from the suppliers to the
14 consumers;
- 15 b. Construct agri-fisheries modernization and food logistics infrastructure towards
16 food security, agricultural resilience, agro-industrialization and improved
17 logistics to achieve cost-efficiency and facilitate exports;
- 18 c. Establish a network of roads, rail, ports and RORO, airports, irrigation, and
19 warehouses based on the food supply and logistics chain;
- 20 d. Accelerate the construction of farm-to-market roads/farm access roads based
21 on an overall network plan;
- 22 e. Provide production and post-harvest facilities such as dryers and warehouses;
23 regional fish ports with modern cold storage; slaughterhouses and other meat
24 establishment facilities; hatcheries, green houses, agricultural tramlines and
25 biosafety facilities;
- 26 f. Provide irrigation to increase farm productivity in rice, corn, sugarcane, and
27 other high value crops;
- 28 g. Construct marketing facilities in strategic agri-fisheries areas such as trading
29 posts, food terminals, auction markets, and fish landing sites. Provide adequate

9 *Sec. 12. Core National Infrastructure Projects.* - The Program shall give priority to

As provided in Section 13 of this Act, the initial list of core national infrastructure projects in this Section shall be regularly updated by the NEDA, to reflect changes in development policies, in economic, physical and social conditions, and in the status of the projects in the Program, among other factors.

Sec. 13. Responsibility for Formulation, Updating and Monitoring of the Detailed 30-Year Program. - Pursuant to the policies, strategies, and other provisions in this Act, the NEDA shall, in coordination with the concerned Oversight and Implementing Agencies and in consultation with concerned stakeholders, be responsible for the formulation of the detailed 30-Year National Infrastructure Program, divided into Medium-Term Programs. This shall include the selection, prioritization, and phasing of the specific projects with their respective descriptions, scopes, cost estimates, priorities, funding requirements, schedules, financing and implementation modalities, and Implementing Agencies. The extent to which the projects in the Program meet the policies and strategies provided in Section 5 and the Agency responsibilities in Sections 6 to 11 of this Act shall generally determine their priority, phasing, and schedule of implementation.

In coordination with the concerned Agencies, the NEDA shall review and update the 30-Year National Infrastructure Program at the end of each Medium-Term Program, or as often as may be necessary, taking into account changes in development policies, in economic, physical and social conditions, and in the status of the projects, among others. This review and update may include addition or deletion of projects or changes in their scopes and schedules, on the basis of actual physical, social, and economic circumstances, with sufficient justifications, according to detailed guidelines to be defined by the NEDA.

In all updates of the Program, priority shall be given to the core infrastructure projects identified in this Act and in such updates.

1 The NEDA, in coordination with the concerned Agencies, shall be responsible for
2 the regular monitoring and evaluation of the Program, including its physical and
3 financial performance as well as socio-economic impact.

4 *Sec. 14. Minimum Budget Allocation for Infrastructure.* - The NEDA and the DBM
5 shall ensure that the total annual budget allocation by the Government for the 30-Year
6 National Infrastructure Program is at least five percent (5%) of the Gross Domestic
7 Product: *Provided*, That the provision of the Constitution mandating that the State shall
8 assign the highest budgetary priority to education, covering both infrastructure and
9 non-infrastructure aspects, is observed.

10 The budget allocation shall be consistent with the long-term expenditure
11 framework of the Government within the budget ceilings set by the Development
12 Budget Coordinating Committee (DBCC), as well as with realistic levels of private sector
13 investments under PPP schemes. The NEDA and the DBM shall also establish the
14 infrastructure budget allocation for each Implementing Agency, taking into account the
15 priorities of the projects as well as the absorptive capacity and performance record of
16 the Agency in project implementation and budget utilization.

17 *Sec. 15. Project Financing and Implementation Modalities.* – The projects under
18 the Program may be implemented by the concerned Agencies under the following
19 generic modalities in accordance with the criteria and Agency responsibilities indicated:

20 a. Conventional Scheme – This is generally applicable to non-financially viable, but
21 economically feasible, projects.

22 1. Financing of design, construction, operation and maintenance, and right-
23 of-way of the project is provided by the national government.

24 2. Design is undertaken by the national government, by itself or through a
25 private designer.

26 3. Construction is undertaken by the national government, by itself or through
27 a private construction contractor.

28 4. Operation and maintenance are undertaken by the NG, by itself or through
29 a private operation and maintenance contractor.

30 b. Design-Build Scheme – This is generally applicable to non-financially viable but
31 economically feasible projects where alternative design-build technologies are feasible.

1. Financing of design, construction, operation and maintenance, and right-of-way of the project is undertaken by the national government.
2. Design is undertaken by the private design-build contractor.
3. Construction is undertaken by the private design-build contractor.
4. Operation and maintenance are undertaken by the national government, by itself or through a private operation and maintenance contractor.

c. PPP Scheme - This is generally applicable to financially viable and economically feasible projects, with cost recovery from user charges or with value for money to the government/public.

1. Financing of right-of-way and allowable subsidy for the project is undertaken by the national government. Financing of design, construction, and operation and maintenance are undertaken by the Private PPP Concessionaire.
2. Design is undertaken by the private PPP concessionaire.
3. Construction is undertaken by the private PPP concessionaire.
4. Operation and maintenance are undertaken by the private PPP concessionaire.

d. Hybrid PPP scheme - This is generally applicable to financially viable and economically feasible projects where ODA is an affordable and quick source of financing for project design and construction, while the PPP Concessionaire can efficiently undertake the operation and maintenance.

1. Financing of right-of-way and allowable subsidies is undertaken by the national government. Financing of design and construction is undertaken by the national government with ODA. Financing of operation and maintenance is undertaken by the private PPP concessionaire.
2. Design is undertaken by the national government, by itself or through a private designer.
3. Construction is undertaken by the national government, by itself or through a private construction contractor.
4. Operation and maintenance are undertaken by the private PPP concessionaire.

1 e. NG-LGU Partnership - This is generally applicable to non-financially viable but
2 economically feasible projects where LGUs can contribute to right-of-way and operation
3 and maintenance.

4 1. Financing of design and construction is undertaken by the national
5 government. Financing of right-of-way/operation and maintenance are
6 undertaken by the LGU.

7 2. Design is undertaken by the national government, by itself or through a
8 private designer.

9 3. Construction is undertaken by the national government, by itself or through
10 a private construction contractor, or by the concerned LGU.

11 4. Operation and maintenance are undertaken by the LGU.

12 Sources of national government and LGU financing may include revenues and
13 loans and grants, including those provided from ODA sources.

14 In addition to these generic project financing and implementation modalities, the
15 NEDA, in coordination with the DOF and other Oversight and Implementing Agencies,
16 may authorize other appropriate modalities, and variants, as deemed feasible for the
17 specific circumstances and requirements of the projects at hand. These may include,
18 among others, green financing, blended financing, and co-financing, for projects that
19 meet minimum Environmental, Social, and Governance (ESG) standards with strong
20 economic impact potentials. Instruments may include national infrastructure bonds and
21 green infrastructure bonds that can attract commercial and sustainable investments.

22 *Sec. 16. Basis for Medium-Term and Annual Programming and Budgeting.* – Based
23 on the Program, the Implementing Agencies shall formulate their respective Medium-
24 Term Infrastructure Programs, which are to be integrated into the overall National
25 Medium-Term Infrastructure Programs and the Medium-Term Philippine Development
26 Plan to be crafted by the NEDA.

27 Based on the Program, the Implementing Agencies shall prepare their respective
28 Medium-Term Expenditure Frameworks (MTEFs) and subsequently their Annual
29 Infrastructure Budgets (AIBs), which are to be integrated into the proposed Annual
30 National Expenditure Programs (NEPs) to be prepared by the DBM, for submission to
31 the Congress as the basis of the annual General Appropriations Acts (GAAs). The

1 Implementing Agencies and the DBM shall see to it that the core projects in the 30-
2 Year National Infrastructure Program are given priority in the MTEFs, AIBs and NEPs.

3 The MTEFs shall be guided by the yearly budget ceilings to be provided by the
4 DBCC. The AIBs shall follow the cash-based budgeting system of the Government.

5 The projects in the initial list under Section 12 of this Act, as well as those in the
6 updates of the Program pursuant to Section 13 of this Act, shall be vetted and approved
7 according to the detailed evaluation criteria set by the NEDA, to confirm their technical,
8 economic, financial, social, and environmental feasibility and priority, before the
9 projects are included in the Medium-Term and Annual Infrastructure Programs and
10 Budgets as provided in Section 10 of this Act.

11 Based on the Program and the approved GAAs, the DBM shall issue the necessary
12 Multi-Year Contracting Authority (MYCA) to cover the total cost of each project whose
13 implementation will span several years. The DBM shall classify projects with issued
14 MYCAs as priority items in the Agency AIBs, and shall provide for the automatic
15 inclusion of the required funds in succeeding NEPs to enable the continuous
16 implementation of such multi-year projects up to their completion.

17 *Sec. 17. Use of Applicable Modern Technology for Project Implementation.* – To
18 achieve efficiency and transparency, projects in this Program shall, where applicable,
19 be procured through electronic online systems, covering the submission and evaluation
20 of bids. For effective management of the projects, Implementing Agencies shall use
21 the Building Information Modeling (BIM) or similar applicable automated management
22 tools that can visualize, simulate, track, and help optimize the performance of a
23 particular infrastructure in five dimensions, namely, length, width, height, time, and
24 cost, throughout the lifecycle of the project, from planning and design, through
25 procurement and construction, to operation and maintenance.

26 *Sec. 18. Implementing Rules and Regulations (IRR).* - Within sixty (60) days from
27 the approval of this Act, a Committee, composed of the following officials, shall
28 promulgate the rules and regulations for the proper implementation of the provisions
29 of the Act:

- 30 a. The NEDA Secretary as Chairperson.
- 31 b. All Members of the NEDA Infrastructure Committee as Members.

1 In preparing the IRR, the Committee shall consult with major stakeholders from
2 the concerned private sectors, business groups, LGUs, community organizations, and
3 Non-Government Organizations, among others.

4 *Sec. 19. Accountability for Formulation and Implementation of this Act.* – The
5 concerned Oversight and Implementing Agencies shall be held accountable, under
6 existing laws, including anti-graft and corrupt practices laws and auditing rules, for the
7 proper performance of their respective responsibilities, covering the selection,
8 prioritization, budgeting, financing, procurement, execution, fund disbursements, and
9 related aspects of the projects in the 30-Year National Infrastructure Program, as
10 provided in this Act.

11 *Sec. 20. Separability Clause.* - If any provision of this Act is declared invalid or
12 unconstitutional, other parts or provisions hereof not affected thereby shall continue to
13 be in full force and effect.

14 *Sec. 21. Repealing Clause.* – All laws, decrees, orders, rules and regulations or
15 parts thereof contrary to, or inconsistent with, this Act are hereby repealed, modified
16 or amended accordingly.

17 *Sec. 22. Effectivity.* –This Act shall take effect fifteen (15) days following its
18 complete publication either in the *Official Gazette* or in at least two (2) newspapers of
19 general circulation in the Philippines.
