IN THE MUNICIPALITY OF TANAY, PROVINCE OF RIZAL

EXPLANATORY NOTE


Section 16, Article II of the 1987 Constitution provides that, *"the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature."*

The barangay is the basic political unit in the country, as provided for by Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991. As such, it *"serves as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community, and as a forum wherein the collective views of the people may be expressed, crystallized and considered, and where disputes may be amicably settled."*

The Sangguniang Panlalawigan of Rizal has adopted Ordinance No. 29, S. 2017 dated December 18, 2017, creating Barangay Madilay-Dilay in the Municipality of Tanay, Province of Rizal, which was subsequently ratified by the conduct of a plebiscite.

Pursuant to Sec. 6, Article X of the Philippine Constitution, Brgy. Madilay-Dilay *"shall have a just share, as determined by law, in the national taxes which shall be automatically released to them."* This bill seeks to ensure that Brgy. Madilay-dilay receives its appropriate Internal Revenue Allotment so that it may carry out its mandate.

For the foregoing reasons, the passage of this bill is earnestly sought.

AN ACT
CREATING A BARANGAY TO BE KNOWN AS BARANGAY MADILAY-DILAY
IN THE MUNICIPALITY OF TANAY, PROVINCE OF RIZAL

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** Creation of Barangay Madilay-dilay. There shall hereby be created
2 barangay to be known as barangay "Madilay-Dilay" in the Municipality of Tanay,
3 Province of Rizal.

4
5 **SEC. 2.** Territorial Boundaries. The territorial boundaries of Barangay Madilay-
6 Dilay shall be identified as follows:

8 Bounded on the SE, along line 1-2 by Cad 720-D Sta. Maria Cadastre, Province
9 of Laguna;

10 On the NW, along lines 2, 3, and 4 by PLS 411-D (PORTION) Tanay, Cadastre
11 Barangay Sampaloc, Municipality of Tanay, Province of Rizal;

12 On the NW, along lines 4, 5, and 6 by portion of GSS-1333-D and Portion of PLS
13 411-D, Barangay Daractan, Municipality of Tanay, Province of Rizal;

14 On the NE, along lines 6-1 by portion of GSS-1333-D Tanay Cadastre,
15 Municipality of Tanay, Province of Rizal;

16 Beginning at a point marked "1" on plan, being S. 64° 23' E., 3,799.46 meters
17 from BLLM No. 28 GSS 1333-D, Tanay Cadastre;

19 Thence S. 71° 39' W., 6,769.59m to point 2;

20 Thence N. 05° 06' E., 1,119.22m to point 3;

21 Thence N. 13° 07' E., 1,329.63m to point 4;

22 Thence N. 60° 16' E., 2,672.66m to point 5;

23 Thence N. 65° 13' E., 1,983.53m to point 6;

24 Thence S. 37° 12' E., 3,398.46m to point of

1 beginning, containing an area of Fifteen Million Ninety-Eight Thousand Two
2 Hundred Forty-Nine and Twenty-Nine Hundredths (15,098,249.29) square

5 **SEC. 3. *Conduct and Supervision of Plebiscite.*** The plebiscite conducted and
6 supervised by the Commission on Elections (COMELEC) pursuant to Provincial
7 Ordinance No. 29, series of 2017, dated December 18, 2017 of the Sangguniang
8 Panlalawigan of Rizal which ratified the creation of Barangay Madilay-dilay as
9 proclaimed by the Plebiscite Board of Canvassers on July 28, 2018, shall serve as
10 substantial compliance with the plebiscite requirement under SEC. 10 of Republic Act
11 No. 7160, as amended, otherwise known as the "Local Government Code of 1991".
12

13 **SEC. 4. *Barangay Officials.*** – The incumbent appointed officials of Barangay
14 Madilay-Dilay shall continue to hold office until such time their successors shall have
15 been duly elected and qualified.
16

17 **SEC. 5. *Public Infrastructure and Facilities.*** – All existing public infrastructure
18 and facilities for public use existing therein at the time of the approval of this Act are
19 hereby transferred without cost of compensation to and shall be administered by the
20 barangay.
21

22 **SEC. 6. *Internal Revenue Allotment (IRA).*** – Barangay Madilay-Dilay in the
23 Municipality of Tanay, province of Rizal shall therefor be entitled to Internal Revenue
24 Allotment (IRA) shares pursuant to SEC. 285 of Republic Act No. 7160, as amended,
25 otherwise known as the Local Government Code of 1991.
26

27 **SEC. 7. *Separability Clause.*** – If any provision of this Act is held unconstitutional
28 or invalid, the remaining provisions which are not affected thereby shall continue to be
29 in full force and effect.
30

31 **SEC. 8. *Repealing Clause.*** – All laws, decrees, executive orders, rules and
32 regulations, and other issuances, or parts thereof, contrary to or inconsistent with this
33 Act are hereby modified, amended, or repealed accordingly.
34

35 **SEC. 9. *Effectivity.*** – This Act shall take effect fifteen (15) days after its
36 publication in the Official Gazette or in a newspaper of general circulation.
