**AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY BUKAL IN  
THE MUNICIPALITY OF NABUNTURAN, PROVINCE OF DAVAO DE ORO**


EXPLANATORY NOTE

Section 9 of Article II of the 1987 Philippine Constitution provides that "*The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all.*"

Given the important role that the basic political unit performs, this proposed measure seeks to create a barangay to be known as Barangay Bukal in the Municipality of Nabunturan, Province of Davao De Oro. This will enable the barangay to better perform its mandate of delivering basic services and facilities to the people in the most efficient and responsive manner.

In addition, this measure seeks to promote the welfare of the barangay by ensuring that the barangay enjoy genuine and meaningful local autonomy and attain full development, namely: automated release of their share from national taxes; transfer of funds to the barangay for the maintenance of roads and bridges; mandatory share of the barangay in taxes, in order to meet the needs of their local populace as well as to alleviate the economic and social plight of the people currently residing in the area.

In view of the foregoing reasons, the passage of this bill is earnestly sought.

**AN ACT**  
**CREATING A BARANGAY TO BE KNOWN AS BARANGAY BUKAL IN THE**  
**MUNICIPALITY OF NABUNTURAN, PROVINCE OF DAVAO DE ORO**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1.** *Creation of Barangay Bukal.* – There is hereby created a barangay  
2 to be known as Barangay Bukal in the Municipality of Nabunturan, Province of Davao  
3 de Oro.

4           The territorial boundaries of Barangay Bukal as described as follows:

5           A parcel of land, situated in the Municipality of Nabunturan, Province of Davao;  
6 Bounded on the North, point 2-3-4-5-6, by Mainit National Park and points 1-2  
7 and 6-7, by barangay Mainit; on the east, points 7-8, by the Municipality of New  
8 Bataan; on the South, points 8-9, by the Municipality of Maco; and on the West,  
9 points 9-1, by the Municipality of Mawab, beginning at a point marked "1" being  
10 located at a point 125 deg. 59, 45" East 7 deg. 29" North; thence

1           Containing an area of approximately THREE THOUSAND AND FIFTY-FIVE (3,055)  
2           HEACTARES. All points referred to are indicated on the map attached.

5           **SEC. 2. *Conduct and Supervision of Plebiscite.*** – The plebiscite conducted and  
6 supervised by the Commission on Elections (COMELEC) pursuant to Provincial  
7 Ordinance No. 03 series of 1993, which was enacted and approved by the Sangguniang  
8 Panlalawigan of Davao on December 15, 1993, which ratified the creation of Barangay  
9 Bukal as proclaimed by the Plebiscite Board of Canvassers, shall serve as a substantial  
10 compliance with the plebiscite requirement under Section 10 of Republic Act No. 7160  
11 as amended, otherwise known as the Local Government Code of 1991.  
12

13           **SEC. 3. *Barangay Officials.*** – The incumbent elected barangay officials of  
14 Barangay Bukal in the Municipality of Nabunturan, Province of Davao de Oro shall  
15 continue to hold office until such time that their successors have been duly elected and  
16 qualified.

18           **SEC. 4. *Public Infrastructure and Facilities.*** – All existing public infrastructure  
19 and facilities for public use existing therein at the time of the approval of this Act are  
20 hereby transferred without cost of compensation to and shall be administered by the  
21 new barangay.

23           **SEC. 5. *Internal Revenue Allotment (IRA).*** – Barangay Bukal in the Municipality  
24 of Nabunturan, province of Davao de Oro shall therefor be entitled to Internal Revenue  
25 Allotment (IRA) shares pursuant to Section 285 of Republic Act No. 7160, as amended,  
26 otherwise known as the Local Government Code of 1991.

28           **SEC. 6. *Effectivity.*** – This Act shall take effect fifteen (15) days after its  
29 publication in the Official Gazette or in a newspaper of general circulation.
