Returned by said Committee with the Committee Report No. 589, recommending that it be approved without amendment on May 9, 1963;
Submitted said Report to the Senate on May 10, 1963;
Passed on second reading by the Senate without amendment on May 20, 1963;

Certified for immediate enactment by the President of the Philippines on May 18, 1963;
Passed on third reading without amendment by the Senate on May 23, 1963;

No. 5615 - An Act to amend certain Sections of Commonwealth Act Numbered Four hundred sixty-six, otherwise known as the National Internal Revenue Code, and for other purposes.

Referred to the Committee on Ways and Means on the same day;
Returned by said Committee with the Committee Report No. 889, recommending that it be approved without amendment on May 20, 1963;
Submitted said Report to the Senate on May 21, 1963;
Passed on second reading by the Senate without amendment on May 23, 1963;
Printed copies distributed to the Senators on the same day;
Certified for immediate enactment by the President of the Philippines on May 20, 1963;
Passed on third reading without amendment by the Senate on May 23, 1963;
Approved by the President of the Philippines on June 22, 1963;
Converted into Republic Act No. 3825.

No. 5616 - An Act converting the Sitios of Decabasan, Deniog, Diagyan and Dilaguidi in the Municipal District of Dilasag, Province of Quezon, into district and independent barrios.

Introduced by Congressman Enverga;
Submitted to the Senate on May 11, 1964;
Referred to the Committee on Provincial and Municipal Governments and Cities on the same day;
Returned by said Committee with the Committee Report No. 2241, recommending that it be approved without amendment on May 11, 1965;
Submitted said Report to the Senate on May 12, 1965;
Passed on second reading by the Senate without amendment on May 17, 1965;
Printed copies distributed to the Senators on the same day;
Passed on third reading without amendment by the Senate on May 20, 1965;
Approved by the President of the Philippines on June 19, 1965;
Converted into Republic Act No. 4248.
