AN ACT AUTHORIZING ANY CORPORATION AND/OR CORPORATIONS TO UNDERTAKE THE CONSTRUCTION OF A SEAWALL EXTENDING FROM THE SOUTH BOUNDARY OF THE CITY OF MANILA TO CAVITE CITY AND FROM THE NORTH BOUNDARY OF THE CITY OF MANILA TO THE MUNICIPALITY OF MARIVELES, PROVINCE OF BATAAN, INCLUDING THE RECLAMATION OF SUBMERGED LANDS UNDER CERTAIN CONDITIONS, AND FOR OTHER PURPOSES,
