### AN ACT

**SEPARATING THE SITIOS OF KAINGGIAN, BUTAC, COSCOSNONG, LONGBOY, BANGCAG, AND BOTIGUE FROM BARANGAY MAN-ATONG IN THE MUNICIPALITY OF SUYO, PROVINCE OF ILOCOS SUR, AND CONSTITUTING THEM INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY BUTAC**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1        **SECTION 1. Creation of Barangay Butac.** – The sitios of Kainggian, Butac, Coscosnong,  
2 Longboy, Bangcag, and Botigue are hereby separated from Barangay Man-atongin in the  
3 Municipality of Suyo, Province of Ilocos Sur, and constituted into a distinct and independent  
4 barangay to be known as Barangay Butac.

6        **SEC. 2. Territorial Boundaries.** – The territorial boundaries of Barangay Butac are hereby  
7 described as follows:

1           **SEC. 3. *Conduct and Supervision of Plebiscite.*** – Pursuant to Section 10 Republic Act  
2 No. 7160, as amended, otherwise known as the Local Government Code of 1991, the new  
3 Barangay Butac shall come into existence upon the affirmation of the majority of the votes cast  
4 in a plebiscite to be conducted and supervised by the Commission on Elections in Barangay  
5 Man-atong in the Municipality of Suyo, Province of Ilocos Sur, within ninety (90) days from the  
6 effectivity of this Act.

7           The expenses for the plebiscite shall be borne by the Municipality of Suyo, Province of  
8 Ilocos Sur.

9           **SEC. 4. *Barangay Officials.*** – The first set of barangay officials of Barangay Butac shall be  
10 appointed by the President of the Philippines and shall hold office until such time that the new  
11 set of officers have been duly elected and qualified.

12           **SEC. 5. *Public Infrastructure and Facilities.*** – All public infrastructure and facilities  
13 existing therein at the time of the approval of this Act are hereby transferred without cost or  
14 compensation to and shall be administered by the new Barangay Butac.

15           **SEC. 6. *National Tax Allotment Shares.*** – Barangay Butac shall be entitled to National  
16 Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as  
17 amended.

18           **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in the  
19 *Official Gazette* or in a newspaper of general circulation.
