**AN ACT**

**DECLARING THE BEGA FALLS LOCATED IN BARANGAY MABUHAY,  
MUNICIPALITY OF PROSPERIDAD, PROVINCE OF AGUSAN DEL SUR,  
AN ECOTOURISM SITE**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

- 1           **SECTION 1.** The Bega Falls located in Barangay Mabuhay, Municipality of  
2 Prosperidad, Province of Agusan del Sur, is hereby declared an ecotourism site. Pursuant  
3 thereto, its development shall be prioritized and supported by the Department of Tourism  
4 (DOT), subject to the rules and regulations governing the development of ecotourism sites.

1            **SEC. 2.** The technical description of the area to be declared an ecotourism site is as  
 2 follows:

1            **SEC. 3.** Within one (1) year after the approval of this Act, the municipal government  
2 of Prosperidad shall, in coordination with the DOT, Department of Environment and Natural  
3 Resources and concerned agencies of the government, prepare a tourism development plan that  
4 shall include the construction, installation and maintenance of such appropriate infrastructure

1 and facilities to enhance tourism in the area: *Provided*. That said development plan shall ensure  
2 the preservation and conservation of the natural beauty and resources of the area: *Provided*,  
3 *further*, That the implementation of the tourism development plan shall be included in the  
4 budget of the municipal government of Prosperidad.

5 **SEC. 4.** The DOT shall assist the municipal government of Prosperidad in the  
6 implementation of the tourism development plan by providing technical assistance in tourism  
7 capacity building. It shall also include the Bega Falls in its national and regional promotion  
8 programs.

9 **SEC. 5.** The funding for the implementation of this Act shall be included in the annual  
10 budget of the municipal government of Prosperidad. The DOT may augment such allocation  
11 with internally-generated funds.

12 **SEC. 6.** Within sixty (60) days from the effectivity of this Act, the municipal  
13 government of Prosperidad shall, in consultation with the DOT and concerned agencies of the  
14 government, promulgate rules and regulations to implement this Act.

15 **SEC. 7.** If any provision of this Act shall be declared unconstitutional or invalid, the  
16 other provisions not affected thereby shall remain in full force and effect.

17 **SEC. 8.** All laws, rules, regulations, presidential decrees and other issuances  
18 inconsistent with any of the provisions of this Act are hereby deemed repealed or amended  
19 accordingly.

20 **SEC. 9.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
21 *Gazette* or in a newspaper of general circulation.
