AN ACT
CREATING A BARANGAY IN THE CITY OF SAN FERNANDO, PROVINCE OF PAMPANGA,
TO BE KNOWN AS BARANGAY PULUNG BULU

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1. *Creation of Barangay Pulung Bulu.*** – There is hereby created a barangay in
2 the City of San Fernando, Province of Pampanga, to be known as Barangay Pulung Bulu.

3 **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of Barangay Pulung Bulu are
4 hereby described as follows:

5 “Barangay Boundary Monument (BBM) 66 - Boundary between Barangay Pulung Bulu and
6 Barangay Telabastagan, City of San Fernando, in the Province of Pampanga;

7 BBM 67 - Boundary between Barangay Pulung Bulu and Barangay Baliti, City of San Fernando, all
8 in the Province of Pampanga;

9 BBM 64 - Boundaries between Barangay Pulung Bulu, City of San Fernando and Barangay
10 Panipuan, City of Angeles, all in the Province of Pampanga;

11 Municipal Boundary Monument (MBM) 9 - Boundaries between Barangay Pulung Bulu, City of San
12 Fernando, and Barangay Panipuan, City of Angeles, all in the Province of Pampanga;

13 MBM 8 - Boundaries between Barangay Pulung Bulu, and Barangays Telabastagan, City of San
14 Fernando, and the City of Angeles, all in the Province of Pampanga.”

1 **SEC. 3. *Conduct and Supervision of Plebiscite.*** – The plebiscite conducted and supervised
2 by the Commission on Elections pursuant to *Sangguniang Panlungsod* Ordinance No. 2002-010
3 dated September 25, 2002, which was duly ratified and proclaimed by the Plebiscite Board of
4 Canvassers on February 4, 2003, shall serve as substantial compliance with the plebiscite requirement
5 under Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government
6 Code of 1991.

7 **SEC. 4. *Incumbent Barangay Officials.*** – The incumbent elected barangay officials of
8 Barangay Pulung Bulu shall continue to hold office until such time that their successors have been
9 duly elected and qualified.

10 **SEC. 5. *Public Infrastructures and Facilities.*** – All public infrastructures and facilities
11 existing therein at the time of the approval of this Act are hereby transferred without cost or
12 compensation to and shall be administered by the new barangay.

13 **SEC. 6. *National Tax Allotment Shares.*** – Barangay Pulung Bulu shall be entitled to
14 National Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as
15 amended.

16 **SEC. 7. *Repealing Clause.*** – All laws, decrees, executive orders, rules, and regulations,
17 which are inconsistent with this Act are hereby repealed or modified accordingly.

18 **SEC. 8. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in the
19 *Official Gazette* or in a newspaper of general circulation.
