AN ACT
CREATING A BARANGAY IN THE CITY OF TAGUIG, TO BE KNOWN AS BARANGAY
NORTH SIGNAL VILLAGE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Creation of Barangay North Signal Village.* – North Signal Village Proper
2 in Barangay Signal Village, City of Taguig is hereby separated from Barangay Signal Village
3 and constituted into a distinct and independent barangay to be known as Barangay North Signal
4 Village.

5 SEC. 2. *Territorial Boundaries.* – The territorial boundaries of Barangay North Signal
6 Village are hereby described as follows:

7 “Bounded on the North by the property of the Bases Conversion and Development
8 Authority (BCDA-Palakol Area and Pinagsama Village Phase II);

9 On the South by Metro Rail Transit Avenue (formerly Cuasay Street);

10 On the East by the property of BCDA (Palakol Area-Pag-asa) and Dream Land Village;

11 and

12 On the West by Enlisted Personnel Housing Village Phase 2, Sampaloc Street and a
13 creek.”

14 SEC. 3. *Conduct and Supervision of Plebiscite.* – The plebiscite conducted and supervised
15 by the Commission on Elections (COMELEC) in Barangay Signal Village pursuant to City
16 Ordinance No. 58, Series of 2008 of the Sangguniang Panlungsod of the City of Taguig, which
17 ratified the creation of Barangay North Signal Village as proclaimed by the City Board of
18 Canvassers on December 28, 2008, shall serve as substantial compliance with the plebiscite

1 requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the
2 Local Government Code of 1991.

4 **SEC. 4. *Incumbent Barangay Officials.*** – The incumbent barangay officials of Barangay
5 North Signal Village, City of Taguig shall continue to hold office until such time that their
6 successors have been duly elected and qualified.

7 **SEC. 5. *Public Infrastructure and Facilities.*** – All public infrastructure and facilities
8 existing therein at the time of the approval of this Act are hereby transferred without cost or
9 compensation to and shall be administered by the new barangay.

10 **SEC. 6. *National Tax Allotment Shares.*** – Barangay North Signal Village shall be entitled
11 to National Tax Allotment (NTA) shares pursuant to Section 285 of the Local Government Code
12 of 1991.

13 **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in
14 the *Official Gazette* or in any newspaper of general circulation.
