AN ACT

PROVIDING FOR THE ELECTION BY DISTRICT OF MEMBERS OF THE SANGGUNIANG PANLUNGSOD AND MEMBERS OF THE SANGGUNIANG PANLALAWIGAN FOR THE CITY OF IMUS, AMENDING FOR THE PURPOSE SECTION 10 OF REPUBLIC ACT NO. 10161, OTHERWISE KNOWN AS THE CHARTER OF THE CITY OF IMUS

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** Section 10 of Republic Act No. 10161 otherwise known as the Charter of
2 the City of Imus is hereby amended to read as follows:

4 “Section 10. *Composition.* – (a) The sangguniang panlungsod, the
5 legislative body of the City, shall be composed of the city vice-mayor as the
6 presiding officer, the twelve (12) regular sanggunian members, the president of
7 the city chapter of the liga ng mga barangay, the president of the panlungsod
8 and pederasyon ng mga sangguniang kabataan and the three (3) sectoral
9 representatives, as members who shall come from the following sectors: one (1)
10 from the women sector; and, as shall be determined by the sangguniang
11 panlungsod within ninety (90) days prior to the holding of the local elections,
12 one (1) from the agricultural or industrial workers sector; and one (1) from the
13 other sectors, including urban poor, indigenous cultural communities or disabled
14 persons.

16 (b) The regular members of the sangguniang panlungsod,
17 SANGGUNIANG PANLALAWIGAN, and sectoral representatives shall be
18 elected in the manner as may be provided by law[.]: *PROVIDED, HOWEVER,*
19 *THAT, FOR PURPOSES OF REPRESENTATION IN THE SANGGUNIANG*

1 PANLUNGSOD, SIX (6) REGULAR MEMBERS, AND FOR
2 SANGGUNIANG PANLALAWIGAN, ONE (1) REGULAR MEMBER,
3 SHALL BE ELECTED FROM EACH OF THE FOLLOWING DISTRICTS
4 COMPRISING A COMPACT, CONTIGUOUS AND ADJACENT TERRITORY.

34 **SEC. 2.** All laws, decrees, executive orders, rules and regulations which are inconsistent
35 with this Act are hereby amended and repealed accordingly.

37 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official*
38 *Gazette* or in a newspaper of general circulation.
