AN ACT

**CONVERTING THE CEBU TECHNOLOGICAL UNIVERSITY-DUMANJUG
EXTENSION CAMPUS IN THE MUNICIPALITY OF DUMANJUG, PROVINCE OF
CEBU, INTO A REGULAR CAMPUS OF THE CEBU TECHNOLOGICAL
UNIVERSITY, TO BE KNOWN AS THE CEBU TECHNOLOGICAL UNIVERSITY-
DUMANJUG CAMPUS, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** This Act shall be known as the "*Cebu Technological University-*
2 *Dumanjug Campus Act*".
3

4 **SEC. 2.** The Dumanjug Extension Campus of the Cebu Technological University
5 (CTU) located in the Municipality of Dumanjug, Province of Cebu, is hereby converted into
6 a regular campus, to be known as the CTU-Dumanjug Campus.
7

8 **SEC. 3.** The CTU-Dumanjug Campus shall primarily provide short-term, technical-
9 vocational, undergraduate, and graduate courses within its areas of competency and
10 specialization, pursuant to the mandate of the CTU, and according to its capability, as the
11 Board of Regents, hereinafter referred to as the Board, may deem necessary to respond to the
12 human resource development needs of the Province of Cebu and Region VII. It is also
13 mandated to undertake research and extension services, and to provide progressive leadership
14 in these areas.
15

16 **SEC. 4.** The CTU-Dumanjug Campus shall be headed by a Campus Administrator who
17 shall be appointed by the Board, subject to its guidelines on qualification standards, and based
18 on the recommendation of a search committee duly constituted for the purpose of selecting
19 the Campus Administrator.

21 **SEC. 5.** The CTU shall ensure that the minimum requirements of the Commission on
22 Higher Education (CHED) for the operation of the CTU-Dumanjug Campus, including those
23 related to its course offerings, are fully complied with.

1 **SEC. 6.** All assets, both real and personal, personnel, and records of the CTU-Dumanjug
2 Campus, as well as its liabilities or obligations, shall be transferred to the CTU. The positions,
3 rights, and security of tenure of faculty members and personnel therein employed under
4 existing laws prior to the conversion into a regular campus shall be respected.
5

6 All parcels of land belonging to the government that shall be occupied by the CTU-
7 Dumanjug Campus shall be the property of the CTU, and shall be titled under its name:
8 *Provided,* That should the campus or the CTU cease to exist or be abolished or should such
9 aforementioned parcels of land be no longer needed by the CTU, the same shall revert to the
10 Municipality of Dumanjug or to the Republic of the Philippines, as the case may be.
11

12 **SEC. 7.** The provisions of Republic Act No. 8292, otherwise known as the “Higher
13 Education Modernization Act of 1997”, shall form part of this Act.
14

15 **SEC. 8.** The amount necessary to carry out the provisions of this Act shall be included
16 in the annual General Appropriations Act (GAA).
17

18 The Municipality of Dumanjug shall continue to provide assistance to the Dumanjug
19 Extension Campus of the CTU until such time that the amount necessary for the operation
20 and maintenance of the CTU-Dumanjug Campus shall be included in the annual GAA.
21

22 **SEC. 9.** Within sixty (60) days from the effectivity of this Act, the Board shall, in
23 consultation with the CHED, issue rules and regulations to implement the provisions of this
24 Act.

26 **SEC. 10.** If, for any reason, any part or provision of this Act is declared invalid or
27 unconstitutional, the remaining parts or provisions not affected shall remain in full force and
28 effect.
29

30 **SEC. 11.** All other laws, presidential decrees, executive orders, rules and regulations
31 contrary to or inconsistent with the provisions of this Act are repealed or modified
32 accordingly.
33

34 **SEC. 12.** This Act shall take effect fifteen (15) days after its publication in the *Official*
35 *Gazette* or in a newspaper of general circulation.
