

EXPLANATORY NOTE

It has long been the clamor of the residents of the municipal district of San Luis, Subprovince of Aurora, to have a more autonomous form of government.

This municipal district, which was created on June 21, 1959 by virtue of Republic Act No. 2452, had during the ensuing fiscal year realized a total annual receipt of ₱12,005.00 or ₱8,000.00 more than the requirement provided for the conversion of a municipal district into a regular municipality under Section 2 of Republic Act No. 1515. Moreover, the rapid economic advancement and progress in civilization in this place can be compared considerably with other regular fifth class municipalities. Roads, bridges and school buildings, and other public works projects were constructed, thereby providing the inhabitants a vital link in transporting their farm produce to the neighboring towns, and giving the children the opportunity to pursue their studies in the elementary level.

In view of the foregoing, this author strongly recommends the conversion of the municipal district of San Luis into a regular municipality.

AN ACT

TO CONVERT THE MUNICIPAL DISTRICT OF SAN LUIS, SUBPROVINCE  
OF AURORA, PROVINCE OF QUEZON, INTO A MUNICIPALITY.

Be it enacted by the Senate and House of Representatives  
of the Philippines in Congress assembled:

- 1 SECTION 1. The Municipal District of San Luis, Sub-  
2 province of Aurora, Province of Quezon, is hereby con-  
3 verted into a municipality.
- 4 SEC. 2. The present mayor, vice-mayor and councilors  
5 of the Municipal District of San Luis shall be the mayor,  
6 vice-mayor and councilors, respectively, of the new muni-  
7 cipality until their successors shall have been elected in  
8 the next regular elections for provincial and municipal  
9 officials and shall have qualified.
- 10 SEC. 3. This Act shall take effect upon its approval.
