Certified for immediate enactment by the President of the Philippines on May 14, 1960;
Passed on second reading by the Senate with amendments on May 19, 1960;
Passed on third reading with amendments by the Senate on May 19, 1960;

Enacted without executive signature on June 19, 1960;

H. No. 1761 - An Act to amend section one hundred ninety-one of the national internal revenue code, as amended. (10 percentage tax)
Introduced by Congressmen Gonzales, Laurel IV, Padilla, Cortes, etc.
Submitted to the Senate on May 19, 1958;
Referred to the Committee on Finance on the same day;
Returned by said Committee with the Committee Report No. 319, recommending that it be approved without amendment on May 20, 1958;
Submitted said Report to the Senate on May 21, 1958;
Certified for immediate enactment by the President of the Philippines on May 6, 1958;
Passed on second reading by the Senate with amendments on May 6, 1958;
Passed on third reading with amendments by the Senate on May 22, 1958;
Amendments of the Senate sent to the House on the same day;
The House agreed to the amendments of the Senate on the same day;
Approved by the President of the Philippines on June 13, 1958;
Converted into Republic Act No. 2072.

Submitted to the Senate on May 19, 1958;

Returned by said Committee with the Committee Report No. 599, recommending that it be approved without amendment on April 10, 1958;
Submitted said Report to the Senate on April 13, 1958;
Certified for immediate enactment by the President of the Philippines on May 6, 1958;
Passed on second reading by the Senate without amendment on May 16, 1958;
Printed copies distributed to the Senators on the same day;
Passed on third reading without amendment by the Senate on May 19, 1958;
Approved by the President of the Philippines on June 19, 1958;
