CONSIDERACIÓN DEL C. R. NO. 1055 (Continuación)

Senator PRIMICIAS. Mr. President, I ask that we now resume consideration of House Bill No. 1055. Senator Púyat will resume the sponsorship.

The PRESIDENT. Resumption of the consideration of House Bill No. 1055 is in order. The gentleman from Manila and Pampanga has the floor.

Senator Púyat. Mr. President and gentlemen of the Senate, the Committee has received the memoranda prepared by the Secretary of Justice on the new positions and promotions appearing in the budget for the courts of first instance and the justices of the peace. Conformably to the recommendation of the Secretary of Justice, the Committee would like to submit these amendments, but I would like to preface these amendments by this explanation. The Secretary of Justice makes no recommendation with regard to the positions for new justices because, according to him, these would be in compliance with the law approved providing for one justice for each municipality. But he has noticed that in proposing the salaries for both old and new positions, in some cases the salaries proposed are beyond the salary ranges for these positions. So, the Committee has adjusted these salaries proposed and will make the recommendations in the form of amendments.

I will start with the new positions for the courts of first instance which the Secretary has recom-
