H. No. 5511 - An Act amending item twenty-five for the Province of Iloilo, paragraph "g", section two of Republic Act Numbered Fourteen Hundred Eleven. (Re Public Works Act).
 Introduced by Congressman Aldeguer;
 Submitted to the Senate on May 15, 1956;
 Referred to the Committee on Public Works and Communications on the same day;

H. No. 5513 - An Act to codify the tariff and customs laws of the Philippines.
 Introduced by the Committee on Ways and Means and the Special Committee on Revision and Codification of Tariff, Customs and all Tax Laws;
 Submitted to the Senate on July 20, 1956;
 Referred to the Committee on Finance on the same day.
 Returned by said Committee with the Committee Report No. 1335, recommending that it be approved with amendments on July 21, 1956;
 Submitted said Report to the Senate on July 24, 1956;
 Passed on second reading by the Senate with amendments on July 24, 1956;
 Certified for immediate enactment by the President of the Philippines on July 13, 1956;
 Passed on third reading with amendments by the Senate on July 24, 1956;
 Amendments of the Senate sent to the House on July 25, 1956;
 Retalled by the Senate on February 4, 1957; returned by the House on February 5, 1957;
 Recommitted to the Committee on Finance for further study on February 6, 1957;
 Reported back by said Committee with the Committee Report No. 1418, recommending that it be approved with amendments on April 26, 1957;
 Submitted said Report to the Senate on April 29, 1957;
 Passed on second reading by the Senate with amendments on May 14, 1957;
 Certified for immediate enactment by the President of the Philippines on May 3, 1957;
 Passed on third reading with amendments by the Senate on May 14, 1957;
 Amendments of the Senate sent to the House on May 15, 1957;
 The House disagreed to the amendments of the Senate, and asked for a conference on May 16, 1957, having designated as representatives on its part Congressmen Ramos, Roy and Marcos;

- The Senate insisted on its amendments, and accepted the conference asked for by the House on May 17, 1957, having appointed as conferees at the same on its part Senators Puyat, Sabido and Mabanag;
- Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on May 23, 1957;
- The House approved the Report of the Conference Committee on May 23, 1957;
- Approved by the President of the Philippines on June 22, 1957, except Secs. 703 and 3204;
- Converted into Republic Act No. 1937.
- H. No. 5514 - An Act to amend item three, title A, page one hundred eighty-eight, section one of Republic Act Numbered Twelve Hundred. (Re Public Works Projects for Negros Occidental)
- Introduced by Congressman Pusey;
- Submitted to the Senate on May 15, 1956;
- Referred to the Committee on Public Works and Communications on the same day.
- H. No. 5515 - An Act changing the name of certain schools in the Municipality of Padada, Province of Davao.
- Introduced by Congressman Veloso (I.L.);
- Submitted to the Senate on May 15, 1956;
- Referred to the Committee on Provincial and Municipal Governments and Cities on the same day;
- Returned by said Committee with the Committee Report No. 1243, recommending that it be approved without amendment on the same day;
- Submitted said Report to the Senate on May 16, 1956;
- Passed on second reading by the Senate without amendment on April 4, 1957;
- Printed copies distributed to the Senators on the same day;
- Passed on third reading without amendment by the Senate on April 11, 1957;
- Approved by the President of the Philippines on June 21, 1957;
- Converted into Republic Act No. 1731.
- H. No. 5516 - An Act appropriating the sum of two hundred fifty thousand pesos as a revolving fund for the construction of additional student dormitories and residences of personnel in the College of Agriculture, University of the Philippines.
