Submitted to the Senate on February 28, 1957;

Referred to the Committee on Codes and Constitutional Amendments on the same day;

Returned by said Committee with the Committee Report No. 1358, recommending that it be approved without amendment on March 2, 1957;

Submitted said Report to the Senate on March 4, 1957;

Passed on second reading by the Senate with amendments on March 5, 1957;

Submitted to the Senate on February 28, 1957;

Referred to the Committee on Commerce and Industry on the same day;

Referred to the Committees on National Enterprises and Commerce and Industry for joint study on March 4, 1957;

Reported back by said Committee with the Committee Report No. 1368, recommending that it be consolidated with S.No. 553, and S. No. 576 into one bill (S.No. 603) and be approved without amendment on March 14, 1957;

Submitted said Report to the Senate on March 15, 1957;

S.No. 584.- An Act amending Section Eleven (B) of Act Numbered Thirteen hundred seventy-one. (Re arrastre charges)

Introduced by Senators Primicias, Delgado and Locsin and filed on February 27, 1957;

Referred to the Committee on Transportation and Public Service on the same day.
