Mr. PRESIDENT:

The Committee on National Defense and Security to which was referred H. No. 6584 introduced by Congressmen Durano, Roces, Roy, Corpus (E. J.), Cabangbang, Juan, Aldeguer, Crisólogo, Kintanar and Abeleda, Congresswoman Consing, Congressmen Peralta, Cruz (E. R.), Zosa, Parayno, López, Bondad, Laurel, Tolentino, Romualdez, Veloso (I. L.), Villareal, Bengzon, Cuenco, Albano, Pérez (A. J.), Cajulis and Gonzales entitled:

THE ANTI-SUBVERSION ACT

has considered the same and has the honor to report it back to the Senate with the following recommendation:

That it be approved with the following amendments:

1. On Page 1, delete the enacting clause.
2. On the same page, delete lines 1 to 4, and in lieu thereof substitute the following: "WHEREAS, IN THE CASES OF PEOPLE VS. EVANGELISTA, ET AL., (57 PHIL. 354) AND PEOPLE VS. CAPADOCIA, ET AL., (57 PHIL. 364), THE SUPREME COURT HAS CATEGORICALLY DECLARED THAT THE COMMUNIST PARTY OF THE PHILIPPINES IS AN ILLEGAL ASSOCIATION ORGANIZED TO DISTURB THE PEACE OF THE COMMUNITY AND THE SAFETY AND ORDER OF THE GOVERNMENT, DISTURB AND OBSTRUCT THE PERFORMANCE BY LAWFUL AUTHORITIES OF THEIR PUBLIC DUTIES, STIR UP THE PEOPLE AGAINST THE LAWFULLY CONSTITUTED AUTHORITIES, AND INCITE THE PEOPLE TO REBELLION AND THE ULTIMATE OVERTHROW OF THE GOVERNMENT."

2-a. On the same page, line 5, delete the initial phrase "by finds and declares that", and substitute the word "WHEREAS," as the beginning of a new paragraph.

3. On the same page, line 9, substitute a semicolon (;) for the period (.).

4. On the same page, line 10, substitute a small letter "T" of the intial word "The".

5. On the same page, line 14, substitute a semicolon (;) for the period (.) after the initial word "laws", and insert thereafter the phrase "AND IS", and then substitute a small letter for the "D" of the word "Dedicated".

6. On the same page, line 18, substitute a semicolon (;) for the period (.) after the terminal word "same".

7. On page 2, line 1, place the word "WHEREAS" as the beginning of the paragraph, and begin the word "Unlike" with a small letter "u".

8. On the same page, line 6, after the word "objectives", substitute the period (.) with a semi colon (;), insert thereafter the word "WHEREAS", as the beginning of a new paragraph and change the capital "U" in the word "Unlike" with a small letter.

9. On the same page, line 7, strike out the word "however,".

10. On the same page, line 14, substitute the period (.) after the word "Constitution" with a semi colon (;),

11. On the same page, line 15, place the word "WHEREAS," before the initial word "The" and change the capital letter "T" thereof with a small letter.

12. On the same page, line 20, after the initial word "aims", substitute the period (.) with a semi colon (;), insert thereafter the phrase "WHEREAS, ALL" as the beginning of a new paragraph, and begin the word "This" with a small letter.

13. On the same page, line 23, after the word "uprising", substitute the period (.) with a semi colon (;) and delete the rest of the line.

14. On the same page, line 24, delete the initial phrase "has been established, therefore, that" and in lieu thereof place the word "WHEREAS," as the beginning of a new paragraph, and between the words "the" and "Communist" insert the phrase "IDEOLOGICAL TIE OF THE".

15. On the same page, line 25, after the word "Philippines", delete the rest of the line and the initial word "power" on line 26, and place in lieu thereof "WITH INTERNATIONAL COMMUNISM".

16. On the same page, line 27, substitute the period (.) with a semi colon (;), and thereafter place the conjunction "AND".

17. On the same page, line 28, strike out the initial phrase "The Congress further finds that" and place in lieu thereof the word "WHEREAS,".

18. On the same page, line 31, strike out the phrase "finds the" and substitute the same with the phrase "THERE IS".

19. On the same page, line 32, substitute the period (.) with a comma (,) and add the following: "PARTICULARLY AGAINST THAT WHICH IS COMMUNIST-INSPIRED:".

20. On page 3, before line 1, insert the enacting phrase: "NOW, THEREFORE, BE IT ENACTED BY THE SENATE AND HOUSE OF REPRESENTATIVES OF THE PHILIPPINES IN CONGRESS ASSEMBLED:".

21. On the same page, delete lines 1 and 2 and the initial word "lawing", of line 3 and place instead the following: "SEC. 1. IN REITERATION OF THE DECLARATION OF THE SUPREME COURT MENTIONED IN THE PREAMBLE HEREOF, THE CONGRESS HEREBY DECLARES".

22. On the same page, line 3, delete the comma (,) after the word "Philippines" and place instead the phrase "TO BE ILLEGAL AND OUTLAWED,".

23. On the same page, line 9, between the words "or" and "of" delete the word "influence" and in lieu thereof place the word "DOMINATION".

24. On the same page, line 11, the phrase "hereby is" should read "IS HEREBY".

25. On the same page, line 23, between the words "or" and "of" delete the word "influence" and in lieu thereof place the word "DOMINATION".

26. On page 4, line 2, between the words "or" and "of" delete the word "influence" and in lieu thereof place the word "DOMINATION".

27. Sections "3", "4", "5", "6", and "7" of the bill should correspondingly be changed to Sections "2", "3", "4", "5", and "6".
