1. H. No. 7015—An Act appropriating one hundred thousand pesos to defray the expenses of a state funeral for Ramon Magsaysay and for the erection of a temporary mausoleum to contain his remains and to defray the funeral and other expenses of all the other persons in his party;
2. H. No. 7003—An Act appropriating the sum of fourteen thousand four hundred pesos to be paid as compensation to the widow of the late Representative Pedro Lopez; and
3. H. No. 6584—The Anti-Subversion Act.

GENTLEMEN OF THE CONGRESS:

In Republic Act No. 1604 the Philippine membership in the International Financing Corporation and the President of the Philippines or his representatives are authorized to sign on behalf of the Government of the Republic of the Philippines the Articles of Agreement of the said Corporation, an affiliate of the International Bank for Reconstruction and Development, of which the Philippines is a member.

The Corporation, in association with private investors, assists in financing the establishment, improvement and expansion of productive private enterprises which would contribute to the development of member countries. The benefits that will accrue as a result of such loans which may be secured from the Corporation are expected to be substantial.

The International Financing Corporation begun operating on July 24, 1956 and the Philippines has subscribed to 166 shares of the Corporation's capital stock at a total cost of P320,000. Legislative action on this measure would make available earlier the source of funds with which to help finance our economic development.

In view therefore, and pursuant to the provisions of Article VI, section 21(2), of the Constitution, I hereby certify to the necessity of the immediate enactment of House Bill No. 7033, entitled:

"An Act appropriating the sum of three hundred thirty-two thousand pesos to pay for the subscription of the Government of the Republic of the Philippines to the capital stock of the International Finance Corporation."
