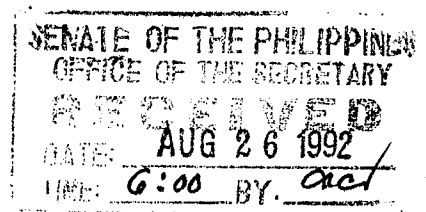

AND FOR OTHER PURPOSES


