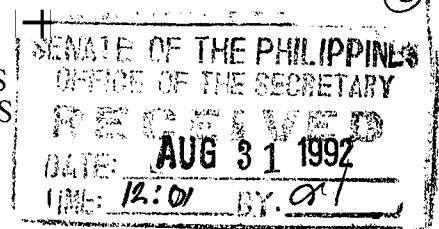

The Communication from the Office of the President certifying to the immediate enactment of a draft measure entitled:




has considered the same and has the honor to report them back to the Senate with the recommendation that S.B. No. 695, substituting said bills, entitled:






