

"AN ACT TO UNIFY GOVERNMENT PLANNING, DEVELOPMENT, REGULATION, AND ADMINISTRATION OF ENERGY ACTIVITIES, INCLUDING ENERGY CONSERVATION, THROUGH THE CREATION OF A DEPARTMENT OF ENERGY AND THE CONVERSION OF THE ENERGY REGULATORY BOARD INTO AN ENERGY REGULATORY COMMISSION";
