The President. So, how will the whole paragraph read now?

Senator Ziga. Only up to "SUBJECT TO VESTED RIGHTS," and "SHALL CONSIDER THE FOLLOWING EVIDENCE OF OWNERSHIP AND POSSESSION."

The President. All right. Is there any objection?

Senator Pimentel. Mr. President, I would have wanted to accept the proposed amendment, but we had a long discussion on the inclusion of this phrase, precisely, because there was an apprehension that without the phrase, lands which are already covered by titles would still be subject to claims that might be brought forward by claimants even if by the Torrens System those claims would already be foreclosed. I do not know if His Honor would insist on it, we can also hear the view of, particularly, Senator Enrile, because he was the most vocal on this point.

Senator Enrile. We will put it into a vote, Mr. President. This Representation will object to that amendment.

The President. Shall we suspend the session?

Senator Pimentel. Maybe we can leave this for tomorrow, Mr. President.

The President. Let us defer discussion of this tomorrow.
