PRIVILEGE SPEECH OF SENATOR TAMANO (On the Philippines and the State of Palestine)

Senator Tamano. Mr. President, distinguished Colleagues, I beg your indulgence in standing here and speaking on the need for us to recognize the State of Palestine formally. Although this is a matter which is really of great importance in the conduct of our foreign relations, particularly our relations with the Muslim World, it has become a matter of personal privilege to your humble servant because I am daily deluged by representations from all sectors of the Muslim community in the Philippines, asking me as their representative in the Senate to make strong representation with our national leaders; that we must act on this urgent matter. It is an urgent matter, Mr. President, because on Monday, the United Nations will decide on the admission of Palestine to the World Health Organization, and it will be embarrassing for our country if we are again out of step with the majority of the Members of the United Nations at a time when we need very much the goodwill of the Muslim community, particularly the Arab countries.

At this point, Mr. President, I rise to commend our distinguished Colleagues, Senator Leticia Ramos Shahani, Chairperson of the Senate Committee on Foreign Relations, and Senator Wigberto Tañada, for cosponsoring a Senate resolution calling for the *de jure* recognition by the Republic of the Philippines of the new State of Palestine as proclaimed in the Palestinian National Council in Algiers on 15 November 1988.

The action of Senators Shahani and Tañada is, indeed, in accordance with the ideals of justice, freedom and selfdeterminations, which are among the cherished traditions of our people.

While I wholeheartedly support this long-delayed initiative which indicates the awakening of our national leaders to the need for the Philippines to adopt an even-handed attitude towards the protagonists in the Israeli-Palestinian conflict, I must state here
