Dr. Samia advised the Committee that a similar bill was passed by both Houses in the Third Congress but was vetoed by the President because this appointing power in the Board of Medical Examiners was removed and three boards were created in the former bill. He pointed out that all these objectionable features were remedied in the present bill. However, he and Drs. Enrile and Fores suggested some amendments to further improve the bill. The Committee decided to report H. No. 2882 with the amendments proposed by the physicians, we consider with the 1817. The Chairman next presented before the Committee the following bills which they unanimously agreed to report out?
