

- S. No. 627 - An Act to regulate the practice of social work agencies in the Philippines and for other purposes.
Introduced by Senator Katigbak and filed on April 3, 1964;
Submitted to the Senate on April 27, 1964;
Referred to the Committee on Revision of Laws on the same day;
Returned by said Committee with the Committee Report No. 1236, recommending that it be approved with amendments on May 5, 1964;
Submitted said Report to the Senate on the same day;
Passed on second reading by the Senate with amendments on April 20, 1965;
Certified for immediate enactment by the President of the Philippines on May 12, 1965;
Passed on third reading by the Senate on May 3, 1965;
Sent to the House requesting concurrence on May 4, 1965;
Passed without amendment by the House on May 19, 1965;
Enrolled copies of the Bill were sent to the President of the Philippines for his action on June 15, 1965;
Approved by the President of the Philippines on June 19, 1965;
(Converted into Republic Act No. 4373).
- S. No. 628 - An Act to further amend Section ten of Republic Act Numbered Three hundred forty, as amended.
Introduced by Senator Marcos and filed on April 6, 1964;
Submitted to the Senate on April 7, 1964;
Referred to the Committee on National Defense and Security on the same day;
(Pending in the Committee).
- S. No. 629 - An Act to amend Section twenty-seven of Republic Act Numbered One hundred eighty. (Re: Elective provincial, municipal, or city officials running for an office).
Introduced by Senator Puyat and filed on April 6, 1964;
Submitted to the Senate on April 8, 1964;
Referred to the Committee on Privileges and Election Laws on the same day;
Returned by said Committee with the Committee Report No. 1082, recommending that it be approved without amendment on April 16, 1964;
Submitted said Report to the Senate on April 20, 1964;
(Pending in the Calendar).
- S. No. 630 - An Act to provide for maternity benefits by the Social Security amending for the purpose Section fourteen of Republic Act Numbered Eleven hundred and sixty-one and Section eight of Republic Act Numbered Six hundred and seventy-nine.
Introduced by Senator Ziga and filed on April 7, 1964;
Submitted to the Senate on April 8, 1964;
Referred to the Committee on National Enterprises on the same day;
Certified for immediate enactment by the President of the Philippines on May 21, 1964;
(Pending in the Committee).
- S. No. 631 - An Act authorizing the appropriation of the sum of seven hundred fifty thousand pesos for the purchase of a parcel of land which shall be the site of the City Hall of the Government of the City of Lucena and for the construction of a City hall building thereto.
Introduced by Senator Ziga and filed on April 7, 1964;
Submitted to the Senate on April 8, 1964;
Referred to the Committee on Public Works and Communications on the same day;
