Senator Tolentino. Mr. President.

CONSIDERATION OF HOUSE BILL NO. 2921 (Continuation)

Senator Tolentino. I move that we resume consideration of House Bill No. 2921, being sponsored by the distinguished gentleman from Rizal and Ilocos Sur.

The PRESIDENT PRO TEMPORE. The distinguished gentleman from Ilocos Sur and Rizal is recognized.

Senator Manglapus. Mr. President, the sponsorship of this bill is finished and we have rather ample discussion on the merits of the bill itself and if there are no more questions to be raised, I move that we go into the period of amendment.

Senator GANZON. Mr. President.

The PRESIDENT PRO TEMPORE. The gentleman from Iloilo is recognized.

Senator GANZON. Just one question to the distinguished gentleman. Now, gentleman from Ilocos Surand Rizal, may I ask you the number one reason, the first, or the most important reason why you are sponsoring this bill, among the many other reasons? You must have a very important reason.

Senator MANGLAPUS. The Committee feels that the bill is of public interest. It is of public interest because we feel that the money that is being spent on the training of these Army officers in the academy is not being taken full advantage of for public good, because instead of being given this chance to serve the full thirty years they are given only twenty-six years after their training.

Senator GANZON. Is it the position of the distinguished gentleman that this bill is the only way wherein we can avail of the services, or to be specific, of the present men now in the Army and who are retirable is to pass this bill so that they can be extended in their number of years of service?

Senator MANGLAPUS. Well, if that question is now to be asked, then I will move to the other reason of the sponsor.

Senator GANZON. I asked that question, gentleman from Ilocos Sur and Rizal, because it appears to me that under existing laws the President of the Philippines, upon considering certain considerations, I am almost sure it is meritorious, can still avail of the services of officers who are retirable by merely extending their services. I think there is a law authorizing the President in doing that. What does the gentleman say?

Senator MANGLAPUS. Yes. That point has been raised, I think, by the gentleman from Laguna and my answer was that it is true that Section 1(b) of the present law gives the President power to extend the service of certain officers. The power is in his hands entirely. My answer was that this would still be applicable if this law is passed. But if this law is not passed then the inequality that exists between PMA graduates and the non-PMA graduates would continue. That is to say, the PMA graduates, at the end of twenty-six years, would have to wait for the President to continue their services, whereas the non-PMA graduates can go up to thirty years before they have to wait for the President to continue them. So that, the present law, while it gives the President the power to continue their services, does not automatically continue the services of the PMA graduates, and the inequality that we are trying to solve will not be solved if we do not pass this bill.

Senator GANZON. Is it not possible, under existing law, gentleman from Ilocos Sur and Rizal, that the President may extend from year to year the services of the officer concerned even though he is retirable this year so that it is possible that that man may even reach sixty years or sixty-five years in the service? Is that possible?

Senator MANGLAPUS. Yes, it is possible, although the record will show that in the past it has never
