AN ACT CHANGING THE NAME OF RIZAL CITY TO PASAY CITY

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The name of Rizal City created by Republic Act Numbered One hundred and eighty-three is hereby changed to Pasay City.

SEC. 2. Whenever the words "Rizal City" appear in Republic Act Numbered One hundred eighty-three, and other acts or part of acts, the said words shall be understood mean or to refer to Pasay City.

SEC. 3. This Act shall take effect upon its approval.

AN ACT TO CREATE THE MUNICIPALITY OF TAWID IN THE PROVINCE OF LEYTE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The barrios of Hilusig, Palanogan, Mahaplag, Malinao, Taga-arag, Union, Uguis, Patong, Paguite, and Balinsasayao, in the Municipality of Abuyog, Province of Leyte, and the barrios of Divisoria, Altavista and Villa Solidaridad, in the Municipality of Baybay, Province of Leyte, are separated from the said municipalities and constituted into a new municipality to be known as the municipality of Tawid with the present site of the barrio of Hilusig as the seat of the municipal government.

SEC. 2. Pending the next general elections, the President of the Philippines shall appoint the elective officials of the new municipality who shall hold office until their successors shall have been duly elected and shall have qualified.

SEC. 3. This new municipality shall belong to the Second District of Leyte.

SEC. 4. This Act shall take effect upon its approval.
