apparatus should at all times be under a person who is proficient in its operation, so that succor to those in distress may be given at the right time. Also, fixing of responsibility in case of accident can easily be determined.

3. On page 3, lines 3, 4, 5, 6, and 7. The phrase "relating to the apparatus, operators and time on duty while at sea, shall be punishable by a fine of not more than one thousand [one hundred] pesos, without prejudice to the liability contracted by him under other laws for the consequences of his neglect" should be eliminated and instead the phrase "SHALL BE SUBJECT TO THE PENALTY HEREIN PRESCRIBED" inserted. Reason: The penal clause is already embodied under Sec. 7. Please note that under this Section, the Commissioner of Customs is the one given the authority to supervise the strict enforcement of the provisions of this Act. Therefore, if the master of the vessel is found violating the provisions stated in the Act, the Commissioner of Customs is the one to try him after administrative proceedings have been filed against him and the penalty to be imposed is provided under Sec. 7.

4. On the same page 3, line 9, the words "see to" should be stricken out and the word "SUPERVISE" inserted. Reason: This is a more appropriate word than "see to".

5. On the same page 3, line 16, between the words "of" and "two" insert the phrase "NOT LESS THAN FIFTY PESOS NOR MORE THAN". Reason: Please note that in page 3, line 12, it states "Seriousness of the offense" and therefore the degree of punishment should be provided as to the minimum and maximum penalties.
