

The PRESIDENT. What does the gentleman from Rizal say?

Senator SUMÚLONG. Well, I will leave it to the Senate, Mr. President.

The PRESIDENT. What does the gentleman from Misamis Oriental say?

Senator PELÁEZ. I also submit it to the Senate. I accept it as an amendment to my amendment, but since the sponsor left it to the Senate, we will have to leave it to the Senate.

The PRESIDENT. Is there any objection to the amendment as amended by the gentleman from Quezon? (*Silence.*) The Chair hears none. The amendment is approved.

Senator SUMÚLONG. Mr. President, for another amendment on page 15, line 17, instead of "contract" it should be "contact". This is a mere misspelling.

Senator SUMÚLONG. Mr. President, for another amendment; on line 18 of page 15, strike out the period (.) after the word "optometrist" and add the following words: "OR OF A PERSON EXEMPTED FROM REGISTRATION UNDER THIS ACT."
