Mr. President, the House of Representatives sent a communication to the Senate informing that it has dissented from our amendments to House Bill No. 3528 which makes the adjusters of insurance claims subject to the Insurance Commissioner in accordance with the provisions of the Insurance Act, and asked for a conference. 1 propose therefore that a conference committee be appointed composed of Senators Sabido, López, and Rodrigo.

MOCIÓN PRIMICIAS

Senator PRIMICIAS. Mr. President, the House informed the Senate that it has approved House Bill No. 5561 regarding the Noli and the Fili, and asks the concurrence of the Senate, but that if the Senate would insist on its bill No. 438, it asks for a con-

As these two bills are exactly the same, the House bill being an exact copy of the Senate bill, in order to avoid the appointment of a conference committee, I ask that the Senate accept the House bill and that both bills to be known as House Bill No. 5561 and Senate Bill No. 438, be readied for the signature of the President.

Senator PELAEZ. Mr. President, will the gentleman yield?

The President. The Gentleman from Pangasinan may yield, if he so desires.

Senator PRIMICIAS. Gladly.

Senator PELAEZ. May I know if the House bill has some kind of an appropriation?

Senator PRIMICIAS. Exactly as the Senate bill.

Senator PELAEZ. If they have asked for a conference committee, would there be time for such committee to report so that the authority may be converted into a direct appropriation?

Senator PRIMICIAS. These two bills are exact copies of each other, to the last comma; there is no need of a conference committee; let us just accept the House bill.

Senator PELAEZ. Would they ask for a conference committee?

Senator PRIMICIAS. If we insist on our bill.

Senator PELAEZ. My view is, if we have time, let us change the authority into direct appropriation. If there is no time for that, I would abide by the decision of the Floor Leader.

Senator PRIMICIAS. The fact is that there is no thing to confer about. There is no dissent.

Senator PELAEZ. I will abide by whatever motion the Floor Leader will make.

Senator PRIMICIAS. It is only a question of what bill to adopt, either the House bill or the Senate bill. So, I ask that the Senate accept the House bill in toto, and that this bill be considered ready for enrollment and signature of the President, but registered as Senate Bill No. 438 and House Bill No. 5551.

The PRESIDENT. Is there any objection in accepting the House version of the Rizal bill? (Silence.)
There being none, the motion is approved.

SEGUNDA LECTURA Y CONSIDERACIÓN DEL C. R. NO. 4598

Senator PRIMICIAS. Mr. President, I now ask that we consider House Bill No. 4598.

The PRESIDENT. Consideration of House Bill No. 4598 is now in order. The Secretary will please read the bill.

The SECRETARY:

AN ACT TO EXTEND THE EFFECTIVITY OF RE-PUBLIC ACT NUMBERED ELEVEN HUNDRED SIXTY-FOUR OTHERWISE KNOWN AS THE "EMERGENCY GOLD MINING ASSISTANCE ACT OF THE PHILIPPINES" BY AMENDING SECTION SEVEN THEREOF AND TO AMEND SECTION TWO, PARAGRAPH (A) AND SECTION FOUR OF SAID LAW.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section two, paragraph (a) of Republic Act Numbered Eleven hundred sixty-four, is hereby amended to read as follows:

"Sec. 2. (a). "Gold producer" or "GOLD MINE" means any person, corporation, partnership, or association which improduced gold in nineteen hundred and fifty-three whether is producing gold either by itself or through an operating agreement on the date of the approval of this act or which engages in the production of gold during the effectivity of this act, either as principal product or as by-product:"

SEC. 2. Section four of Republic Act Numbered Eleven hundred and sixty-four is amended to read as follows:

Sec. 4. Mines with gold as principal product OR AS BY-PRODUCT.—Newly mined gold produced as principal product OR AS BY-PRODUCT—Newly mined gold either to the Government through the Central Bank in the form of refined gold at the current official price per ounce plus the assistance provided in section six hereof or in the domestic free market without benefit of the assistance, at the choice of the gold producer: PROVIDED HOWEVER, THAT AT LEAST FIFTY PER CENTUM OF ALL NEWLY-MINED GOLD PRODUCED BY EACH MINE ETHER AS PRINCIPAL PRODUCT OR AS BY-PRODUCT SHALL BE SOLD TO THE GOVERNMENT IN ACCORDANCE WITH THE PROVISIONS OF THIS ACT: AND PROVIDED FURTHER, THAT MINES PRODUCING GOLD AS BY-PRODUCT SHALL ONLY BE ENTITLED TO THE ASSISTANCE GIVEN TO MINES OVER THE MARGINAL CLASSIFICATION."

SEC. 3. The Board may, at its discretion, exclude from the benefits of this Act any mine which may be found, upon due hearing, to be discriminating against Filipino technical men, employees and/or laborers.

SEC. 4. Section seven of Republic Act Numbered Eleven hundred sixty-four, is amended to read as follows:

"Sec. 7. Term.—This direct short term assistance shall be effective for a period of FOUR [two] years from the date of approval of this Act."

SEC. 5. This Act shall take effect upon its approval.

Senator PRIMICIAS. Mr. President, the sponsor of the measure is the distinguished gentleman from Misamis Oriental, Senator Peláez.

The PRESIDENT. The sponsor has the floor.

PONENCIA DEL SEN. PELÁEZ

Senator Peláez. Mr. President, two years ago we approved Republic Act No. 1164 known as the Emergency Gold Mining Assistance Act of the Philippines. This Act is due to expire on June 19, 1956. At the present moment, the gold industry is still in need of assistance. Therefore, this bill, House Bill No. 4598, has been filed extending the life of the law for two years aside from extending the period of the law. This bill seeks to include within the purview of this Act the gold which is produced as by-products of mines which are not gold mines, such as the copper mines, and other mining enterprises. There is no question as to the necessity of this Act. About twenty thousand laborers are involved and it is necessary that we must continue this assistance.

El Sen. LOCSIN. Señor Presidente, para algunas preguntas al orador.

El Sen. Peláez. No tengo ahora esos datos en mi poder. Pero se dieron a conocer caundo se aprobó el proyecto de ley originalmente. Si Vuestra Seño-
