The SECRETARY:

AN ACT CREATING THE BARRIO OF LIMBUJAN IN THE MUNICIPALITY OF GENERAL MACARTHUR, PROVINCE OF SAMAR.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The sitio of Limbujan in the Municipality of General MacArthur, Province of Sámar, is converted into a barrio of said municipality, to be known as the barrio of Limbujan.

SEC. 2. This Act shall take effect upon its approval.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The seat of government of the Municipality of Hagonoy, Province of Dávaeo, is hereby transferred to the site of barrio of Pawa.

SEC. 2. This Act shall take effect upon its approval.

AN ACT CREATING CERTAIN BARRIOS IN THE MUNICIPALITY OF PATNONGON, PROVINCE OF ANTIQUE.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The following sitios in the Municipality of Patnoñgon, Province of Antique, are constituted as distinct and independent barrios, to wit:

1. The sitios of Magranging, Tigangcal, Agsaman, Egpas, Epayo and Eglapang, to be known as the barrio of Alvañiz;
2. The sitios of Igtuba Maradiona and Igtuba Aureliana, to be known as the barrio of Magsaysay;
3. The sitios of Amarong, Tagbacan, Da-o, Yapo and Embalodan, to be known as the barrio of Elio; and
4. The sitios of Tigabobo, Tiglomabong, Maybangcal, Calagtiñgan and Bongboñgan, to be known as the barrio of Vista Alegre.

SEC. 2. This Act shall take effect upon its approval.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The sitios of Siguinon, Lusod, Cantomoha, Hagnaya and Karapdapan in the Municipality of Salcedo, Province of Samar, are converted into barrios of said municipality, to be known as the barrios of Siguinon, Lusod, Cantomoha, Hagnaya and Karapdapan, respectively.

SEC. 2. This Act shall take effect upon its approval.

SECTION 1. Suribao River is hereby made the boundary between the municipalities of Borongan and Maydolong, Province of Samar.

SEC. 2. This Act shall take effect upon its approval.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The sitios of Bañon, Lero, Canmanila and Canaguini-an, all in the Municipality of Basey, Province of Samar, are hereby converted to a barrio to be known as Barrio Bacubac of the same municipality.

SEC. 2. This Act shall take effect upon its approval.
