

1177 - AN ACT granting Felix Alberto and Company, Incorporated, a franchise to establish radio stations for domestic and transoceanic telecommunications;
 Introduced by Cong. Durano;
 Submitted to the Senate on April 30, 1958;
 Referred to the Committee on Banks, Corporations and Franchises on the same day;
 Returned by said Committee with the Committee Report No. 268, recommending that it be approved with amendments on May 13, 1958;
 Submitted said Report to the Senate on the same day;
 Passed on second reading by the Senate with amendments on May 21, 1958;
 Certified for immediate enactment by the President of the Philippines on May 21, 1958;
 Passed on third reading with amendments by the Senate on May 21, 1958;
 Amendments of the Senate sent to the House on the same day;
 The House agreed to the amendments of the Senate on the same day;
 Enacted without executive signature on June 22, 1958;
 Converted into Republic Act No. 2090.

1181 - AN ACT granting the Gapan Electric Corporation a franchise for an electric light, heat and power system in the Municipalities of Gapan and San Isidro, Province of Nueva Ecija.
 Introduced by Cong. Mercado, Yñiguez and Ocampo;
 Submitted to the Senate on May 16, 1958;
 Referred to the Committee on Banks, Corporations & Franchises on the same day;
 Returned by said Committee with the Committee Report No. 338, recommending that it be approved without amendment on May 21, 1958;
 Submitted said Report to the Senate on May 22, 1958;
 Passed on second reading by the Senate with amendments on May 10, 1960;
 Printed copies distributed to the Senators on May 11, 1960;
 Passed on third reading with amendments by the Senate on May 14, 1960;
 Amendments of the Senate sent to the House on the same day;
 The House agreed to the amendments of the Senate on May 17, 1960;
 Enacted without executive signature on June 19, 1960;
 Converted into Republic Act No. 3013.

1182 - AN ACT creating certain barrios in the Municipality of Patnongon, Province of Antique.
 Introduced by Cong. Fornier;
 Submitted to the Senate on May 19, 1958;
 Referred to the Committee on Prov. & Mun. Gov'ts and Cities on the same day;
 Returned by said Committee with the Committee Report No. 304, recommending that it be approved without amendment on May 19, 1958;
 Submitted said Report to the Senate on May 20, 1958;
 Passed on second reading by the Senate without amendment on February 27, 1959;
 Printed copies distributed to the Senators on the same day;
 Passed on third reading without amendment by the Senate on March 4, 1959;
 Enacted without executive signature on April 24, 1959;
 Converted into Republic Act No. 2164.
