SEC. 14. EFFECT OF DECISION THAT TAX IS BARRED BY STATUTE OF LIMITATIONS.—IF THE ASSESSMENT OR COLLECTION OF ANY TAX IS BARRED BY ANY STATUTE OF LIMITATIONS, THE DECISION OF THE COURT TO THAT EFFECT SHALL BE CONSIDERED AS ITS DECISION THAT THERE IS NO DEFICIENCY IN RESPECT OF SUCH TAX.

SEC. 16. PUBLICITY OF PROCEEDINGS AND PUBLICATION OF DECISIONS .__ALL DECISIONS OF, AND ALL EVIDENCE RECEIVED BY THE COURT AND ITS DIVISION, INCLUDING TRANSCRIPT OF STENOGRAPHIC REPORTS OF THE HEARINGS, SHALL BE PUBLIC RECORDS OPEN TO THE INSPECTION OF THE PUBLIC, EXCEPT THAT AFTER THE DECISION OF THE COURT IN ANY PROCEEDING HAS BECOME FINAL THE COURT MAY, UPON MOTION OF THE TAXPAYER OR THE GOVERNMENT, PERMIT THE WITHDRAWAL, BY THE PARTY ENTITLED THERETO OF ORIGINALS OF BOOKS, DOCUMENTS AND RECORDS, AND OF MODELS, DIAGRAMS, AND OTHER EXHIBITS, INTRODUCED IN EVIDENCE BEFORE THE COURT OR ANY DIVISION; OR THE COURT MAY, ON ITS OWN MOTION MAKE SUCH OTHER DISPOSITION THEREOF AS IT DEEMS ADVIS-ABLE. THE COURT SHALL PROVIDE FOR THE PUBLICATION OF ITS DECISIONS IN THE OFFICIAL CAZETTE IN SUCH FORM AND MANNER AS MAY BE BEST ADOPTED FOR PUBLIC INFORMATION AND USE.

ALL CASES INVOLVING DISPUTED ASSESSMENT OF INTERNAL EVENUE TAXES OR CUSTOMS DUTIES PENDING DETERMINATION BEFORE THE COURT OF FIRST INSTANCE SHALL BE CERTIFIED AND REMANDED BY THE RESPECTIVE CLERK OF COURT TO THE COURT OF TAX APPEALS FOR FINAL DISPOSITION THEREOF.

SEC. 23 SEPARABILITY CLAUSE.—IF ANY CLAUSE, SENTENCE, PARAGRAPH OR PART OF THIS ACT SHALL BE ADJUDGED BY ANY COURT OF COMPETENT JURISDICTION TO BE INVALID, SUCH JUDGMENT SHALL NOT AFFECT, IMPAIR OR INVALIDATE THE PEMAINDER OF THIS ACT, BUT SHALL BE CONFINED IN ITS OFERATIONS TO THE CLAUSE, SENTENCE, PARAGRAPH OR PART THEREOF DIRECTLY INVOLVED IN THE CONTROVERSY.

26. The title of the bill be change so as to read as follows: AN ACT CREATING THE COURT OF TAX APPEALS.

While I do not like to quarrel

with anybody, I would like to suggest that the Congressman from Dávao better devote himself to improving the welfare of the people of Dávao instead of trying to take a mean manner of revenging himself for personal slights by changing the name of a town from the name of the late wife of ex-President Quirino to some other name.
