

S.No. 663.- (Cont.)

Passed on second reading by the Senate with amendments by way of substitution on May 14, 1957;
Printed copies distributed to the Senators on May 15, 1957;
Passed on third reading by the Senate on May 18, 1957;
Sent to the House requesting concurrence on May 20, 1957;
The House having passed a Bill (H. No. 6220) similar to this Bill, and owing to discrepancies found in the provisions of the two measures, said House asked for a conference on May 21, 1957; having designated as representatives on its part Congressmen Babao, Bernido and Abeleda;
The Senate insisted on its Bill and accepted the conference asked for by the House on May 22, 1957, having appointed as conferees at the same on its part Senators Kanglaon, Cuenco and Alonto;
Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on May 22, 1957;
The House approved the Report of the Conference Committee on the same day;
Enrolled copies of the Bill were sent to the President of the Philippines for his action on June 12, 1957;
Vetoed by the President of the Philippines on June 22, 1957.

S.No. 664.- An Act further amending Section Twelve of Commonwealth Act 186, as amended, by prescribing two other modes of retirement and for other purposes.

Introduced by Senator Zulueta and filed on May 6, 1957;
Submitted to the Senate on May 16, 1957;
Referred to the Committee on Civil Service on the same day;
Returned by said Committee with the Committee Report No. 1504, recommending that it be approved without amendment on May 6, 1957;
Submitted said Report to the Senate on May 7, 1957;
Passed on second reading by the Senate without amendments on May 15, 1957;
Printed copies distributed to the Senators on May 17, 1957;
Passed on third reading by the Senate on May 20, 1957;
The House having passed a Bill (H. No. 7433) similar to this Bill, and owing to discrepancies found in the provisions of the two measures, the Senate asked for a conference on May 23, 1957, having designated as representatives on its part Senators Zulueta, Coa and Delgado;
The House insisted on its Bill and accepted the conference asked for by the Senate on the same day, having appointed as conferees at the same on its part Congressmen Peralta, Salvador and Benito;
Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on the same day;
Enrolled copies of the Bill were sent to the President of the Philippines for his action on May 31, 1957;
Approved by the President of the Philippines on May 31, 1957;
Converted into Republic Act No. 1616.

S.No. 665.- An Act to amend certain items in Republic Act Numbered Fourteen hundred eleven regarding public works projects for the Province of Camarines Sur.
Introduced by Senator Coa and filed on May 6, 1957;
