Senator PRIMICIAS. Mr. President, I ask that we resume consideration of House Bill No. 2405.

The PRESIDENT. Consideration of House Bill No. 2405 is in order.

Senator PRIMICIAS. Mr. President, the gentleman from Bulacán will resume the sponsorship.

The PRESIDENT. The gentleman from Bulacán has the floor.

Senator RODRIGO. Mr. President, the last time, the consideration of this bill was suspended, we were considering the amendment to the amendment presented by the gentleman from Quezon.

RETIRADA DE LA ENMIENDA TAÑADA

Senator TAÑADA. Mr. President, the amendment to the amendment which I introduced reads as follows: "Provided, however, that in cases of emergency where a duly registered physician is not immediately available, a physio-therapist may administer treatment without the aforementioned requirement." In order to expedite the approval of this bill and in order not to lengthen unduly the discussion of this bill, I am withdrawing this amendment.

The PRESIDENT. The amendment is withdrawn. Senator RODRIGO. In that case, we will have to vote on the amendment of the Committee.

The PRESIDENT. What is the amendment?

Senator RODRIGO. The amendment is this: On page 6, between lines 18 and 19 insert a new section to be known as Section 13 which will read as follows:

"SECTION 13. Limitation of practice of physio-therapist. A physio-therapist shall not practice his profession on any individual except upon the written recommendation or prescription of a duly registered physician. This limitation shall be enforced for a period of four years from the approval of this Act."

Senator I.M. Mr. President, will the gentlemen yield?
