Senator Osmeña III. Yes, Mr. President, there are a few committee amendments, just an oversight on my part and I take the blame for this. But it is just very short.

The President Pro Tempore. Please proceed.

#### **COMMITTEE AMENDMENTS**

Senator Osmeña III. On page 2, lines 11 to 15, delete the entire subsection "EXEMPTION FROM PAYMENT OF INDIVIDUAL INCOME TAXES; PROVIDED, THAT THEIR ANNUAL TAXABLEINCOMEDOESNOT EXCEED THE POVERTY LEVEL AS DETERMINED BY THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA) FOR THAT YEAR."

We propose to delete this entire section. It is going to be very difficult for the BIR, and besides, if they fall below the poverty level they have no income tax to pay.

The President Pro Tempore. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Osmeña III. And an omnibus motion to renumber all sections subsequent to that. On page 4, line 16, after the word "SUBMISSION", insert the phrase OF ANY OF THE FOLLOW-ING. That is the extent of our amendment.

The President Pro Tempore. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Osmeña III. On the same page, same line, after the word "THERETO", delete the phrase "ANY OF THE FOLLOW-ING". We are just repositioning.

The President Pro Tempore. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Osmeña III. On the same page, line 18, after the article "AN" delete the acronym "ID" and in lieu thereof insert the words IDENTIFICATION CARD.

Senator Osmeña III. On page 6, line 16, after the word "against", delete the words "DISABLED PERSONS" and in lieu thereof insert the words PERSONS WITH DISABILITY.

Senator Osmeña III. On page 7, line 7, after the word "INTO" correct the spelling of the word DEGRADATION. It is spelled "DEGRATION". That should be DEGRADATION, Mr. President.

The President Pro Tempore. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Osmeña III. On the title of the bill, after the words "ANACT", delete the words "GRANTING OTHER PRIVILEGES AND INCENTIVES TO PERSONS WITH DISABILITY AND GRANTING THEM THE RIGHT TO LIVE FREE FROM VERBAL AND NON-VERBAL RIDICULE AND VILIFICATION...."

The President Pro Tempore. Is that the extent?

Senator Osmeña III. Yes, that is the extent of the amendment, Mr. President.

The President Pro Tempore. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Osmeña III. After the word "AMENDING" on the third line of that, insert the words FOR THE PURPOSE....Excuse me, Mr. President. Ah, to delete the phrase "FOR THE PURPOSE".

The President Pro Tempore. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Osmeña III. And that shall be the extent of our amendment, Mr. President.
