BILL ON THIRD READING S. No. 2636 – August 21 as Ninoy Aquino Day

Senator Legarda. Mr. President, before we proceed to the Reference of Business, I move that we vote on Third Reading Senate Bill No. 2636. Copies of the bill were distributed to the members on August 25, 2003.

The President. Is there any objection? [Silence] There being none, voting on Third Reading on Senate Bill No. 2636 is now in order. The Secretary will please read only the title of the bill.

So that my proposal would, therefore, be, after the word "annually" in line 16, delete the words "to be administered by a trustee appointed and supervised by the court" and add the following phrase: FOR WHICH HE OR SHE SHALL RENDER A SEMIANNUAL ACCOUNTING—in other words, twice a year— OF THE FUND TO THE DSWD.

The President. The session is resumed. Senator Pimentel is once more recognized.

Senator Pimentel. Mr. President, with the permission of the sponsor, may we introduce the following amendment in lines 16 and 17. After the word "annually", delete the words "to be administered by a trustee appointed and supervised by the court" and add the following: FOR WHICH HE OR SHE SHALL RENDER A SEMIANNUAL ACCOUNTING OF THE FUND TO THE DE-PARTMENT OF LABOR AND EMPLOYMENT.

Senator Magsaysay. We accept the amendment, Mr. President. I understand also that Senator Pimentel wanted to delete Section 16.

Senator Pimentel. Yes.

The President. Before we do that, can we first act on this amendment of Senator Pimentel?

Is there any objection to the Pimentel amendment in lines 16 and 17? [Silence] There being none, the amendment is approved.

Now, we go back to Section 16, lines 5 to 11. What is the pleasure of Senator Pimentel?

Senator Pimentel. I move to delete the entire section, Mr. President.

Senator Magsaysay. We have no objection, Mr. President.

The President. All right, there being no objection, the amendment is approved.

Senator Pimentel. In which case, Mr. President, that deletion will affect not only the renumbering but also page 16, lines 16 and 17, because this speaks of violations of the provisions of Section 16 of this Act.

The President. All right. So, 16 would be deleted?

Senator Pimentel. Yes, lines 16 ...

The President. Lines 16 and 17 on page 16. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Pimentel. And, of course, the renumbering of the ...

The President. And so in line 18, Section 17, should now refer to Section 16.

Senator Pimentel. That is correct, Mr. President.

The President. And there will be renumbering accordingly.

Senator Pimentel. Accordingly, Mr. President. Also on page 12 up to page 13, my proposed amendment has to do with the membership of the National Committee on Child Labor. I would like to propose that we reduce the number of members of the National Committee on Child Labor as follows, Mr. President.

DRILON-PIMENTEL AMENDMENT

Senator Pimentel. Mr. President, after that one- minute break, upon suggestion of the Senate President and the sponsor, together we have come to the conclusion that it would be best that the entire Article 7 that starts from page 12 up to page 14, line 6, will have to be deleted with the understanding that the rules and regulations to be hammered out to get the provisions of this Act implemented will contain a reference that the Bureau of Women and Young Workers of the Department of Labor and Employment shall be the Secretariat only for purposes of getting this law implemented.

DRILON AMENDMENT

The President. If the Chair may suggest, subject to style, Section 29 will be reworded to read as follows: "The Bureau of Women and Young Workers of the Department of Labor and EmploymentshallbeRESPONSIBLEFOR IMPLEMENTING THIS LAW.

Senator Pimentel. Yes. That would be perfectly acceptable, Mr. President.

The President. Is that acceptable to the sponsor?

Senator Magsaysay. We have no objection. This is to lessen the bureaucracy. It is accepted, Mr. President.

The President. All right. With the permission of Senator Pimentel, we can delete on page 12 from line 10 down to...

Senator Pimentel. Yes, Mr. President. From line 9, actually.

The President. Line 9 refers to Article VII.

Senator Pimentel. Yes. All right, Mr. President.

The President. From line 10 up to page 14, line 3, all deleted. Section 29 will now be retitled *IMPLEMENTING AGENCY* and then we say: "The Bureau of Women and Young Workers of the Department of Labor and Employment shall IMPLEMENT THE PROVISIONS OF THIS ACT."

Senator Pimentel. That is perfect, Mr. President.

The President. Is that acceptable to the sponsor?

Senator Magsaysay. Yes. It is accepted, Mr. President.

The President. Is there any objection to the amendment as proposed by the Chair? [Silence] There being none, the amendment is approved.

Senator Pimentel. That will be all for my amendments, Mr. President. Thank you very much.

The President. Are there any other amendments?

Senator Magsaysay. Mr. President, there are several sections that have been removed so this becomes Section 26, and to be resectionized.

The President. Yes, the renumbering.

Senator Magsaysay. It will be renumbered.

The President. Are there any other amendments? [Silence] If there are no other amendments, with the permission of the Chamber, the period of amendments is hereby terminated.

Senator Magsaysay. Thank you, Mr. President.

The President. The Chair is now ready to receive the motion to approve the measure on Second Reading.

APPROVAL OF S. NO. 2155 ON SECOND READING

Senator Legarda. Mr. President, I move that we vote on Second Reading on Senate Bill No. 2155, as amended.

The President. Is there any objection? [Silence] There being none, we shall now vote on Second Reading on Senate Bill No. 2155, as amended.
