

- 381 - An Act to amend subtitle (e) of Title (D) section one of Republic Act Numbered One thousand three hundred fifty entitled "An Act Appropriating funds for the operation of the Government of the Republic of the Philippines during the period from July first, nineteen hundred fifty-five to June thirtieth, nineteen hundred and fifty-six and for other purposes" (re Philippine mission in Vatican City);  
 By Senator Magalona and filed on July 1, 1955;  
 Submitted to the Senate on January 24, 1956;  
 Referred to the Committee on Finance on the same day;  
 Pending in the Committee on Finance).
- 382 - An Act to amend Sections 3, 7, 10, 13, 14, 15, 17, and 18 of Republic Act Numbered Twelve hundred and sixty-seven entitled "An Act creating the Court of Agrarian Relations, prescribing its jurisdiction, and establishing its rules of procedure";  
 By Senator Primicias and filed on July 6, 1955;  
 Submitted to the Senate on July 7, 1955;  
 Referred to the Committee on Justice on the same day;  
 Returned by said Committee with the Committee Report No. 382, recommending that it be approved without amendment on the same day;  
 Submitted said Report to the Senate on the same day;  
 Passed on second reading by the Senate with amendments on July 11, 1955;  
 Certified for immediate enactment by the President of the Philippines on July 8, 1955;  
 Passed on third reading by the Senate on July 11, 1955;  
 Sent to the House requesting concurrence on July 12, 1955;  
 The House having passed a Bill (H. No. 4506) similar to this Bill, and owing to discrepancies found in the provisions of the two measures, the Senate asked for a conference on July 16, 1955 having designated as representatives on its part Senators Laurel, Mabanag and Paredes;  
 The House concurred on its Bill and accepted the conference called for by the Senate on July 23, 1955 having appointed as conferees at the same on its part Congressmen Laurel, Muntanar and Perez (A.J.);  
 Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the discrepancies of both Houses, and agreed to by the Senate on August 8, 1955;  
 The House concurred the Report of the Conference Committee on August 8, 1955;  
 (See House Report No. 4506)  
 Approved by the President of the Philippines on September 15, 1955;  
 Converted into Republic Act No. 1409.
- 383 - An Act to amend Republic Act Numbered Twelve hundred and forty-five entitled "An Act amending Section Twenty-Two hundred nineteen and other provisions of the Revised Administrative Code and for other purposes" or related provisions of the same Code;  
 By Senator Primicias and filed on July 6, 1955;  
 Submitted to the Senate on July 7, 1955;  
 Referred to the Committee on Rural Development on the same day;  
 Returned by said Committee with the Committee Report No. 383, recommending that it be approved without amendment on the same day;  
 Submitted said Report to the Senate on the same day;  
 Passed on second reading by the Senate with amendments by substitution on July 12, 1955;  
 Certified for immediate enactment by the President of the Phi-

Philippines on July 8, 1955;  
Passed on third reading by the Senate on July 13, 1955;  
Sent to the House requesting concurrence on July 14, 1955;  
Passed with amendments by the House on July 21, 1955;  
The Senate disagreed to the amendments of the House, and asked  
for a conference on July 28, 1955 having appointed as conferees on its part Senators Cabill, Cuenco and Peralta, Jr.;  
The House insisted on its amendments, and accepted the conference asked for by the Senate on August 1, 1955 having designated as representatives on its part Congressmen Macias, Hora and Abeleda;  
Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on August 8, 1955;  
The House approved the Report of the Conference Committee on August 9, 1955;  
Enrolled copies of the Bill were sent to the President of the Philippines for his action on August 24, 1955;  
Approved by the President of the Philippines on September 9, 1955;  
Converted into Republic Act No. 1408.

384 - An Act to prohibit the so-called "No-Dollar" imports except under certain conditions;  
By Senator Cea, and filed on July 7, 1955;  
Submitted to the Senate on July 8, 1955;  
Referred to the Committee on Commerce and Industry on the same day;  
Returned by said Committee with the Committee Report No. 885, recommending that it be approved with amendment on July 11, 1955;  
Submitted said Report to the Senate on the same day;  
Passed on second reading by the Senate with amendments on July 13, 1955;  
Certified for immediate enactment by the President of the Philippines on July 8, 1955;  
Passed on third reading by the Senate on July 14, 1955;  
Sent to the House requesting concurrence on the same day;  
Passed with amendments by the House on July 19, 1955;  
Amendments of the House referred to the Committee on Commerce and Industry on July 21, 1955;  
The Senate disagreed to the amendments of the House, and asked for a conference on July 21, 1955 having appointed on its part Senators Cea, Locsin and Peralta, Jr.;  
The House insisted on its amendments, and accepted the conference asked for by the Senate on July 25, 1955 having designated as representatives at the same on its part Congressmen Durano, Alonto and Marcos;  
Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on August 4, 1955;  
The House approved the Report of the Conference Committee on the same day;  
Enrolled copies of the Bill were sent to the President of the Philippines for his action on August 24, 1955;  
Converted into Republic Act No. 1410, on September 10, 1955, without Executive approval.

385 - An Act authorizing the appropriation of the sum of five million pesos to implement Republic Act No. 899 which creates a revolving fund to finance irrigation projects by private initiative;
