WHEREAS, it is necessary that inquiries and investigations in aid of legislation be continued even during the recess of Congress in order that appropriate recommendations and measures may be adopted and made for submission to Congress at its next meeting; Now, Therefore, be it

Resolved, by the Senate, that all Committees of the Senate be authorized, as they are hereby authorized, to function during the recess, after the present special session of Congress.

## SEGUNDA LECTURA Y CONSIDERACIÓN DEL S. NO. 377

Senator PRIMICIAS. I now ask for the immediate consideration of Senate Bill No. 377.

The ACTING PRESIDENT. Consideration of Senate Bill No. 377 is in order. The Secretary will read the bill.

#### The SECRETARY:

AN ACT TO PROVIDE A SOUND BASIS FOR FOREIGN CAPITAL INVESTMENT IN THE PHILIPPINES, PROVIDING FOR THE ADMINISTRATION OF THIS ACT BY THE NATIONAL ECONOMIC COUNCIL, APPROPRIATING ADDITIONAL FUNDS IN CONNECTION THEREWITH, AND FOR OTHER PURPOSES.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. This Act shall be known as the Foreign Investment Law.

SEC. 2. Purpose.—It is the purpose of this law to establish a sound basis for foreign capital investment in the Philippines. Toward this end, subject to constitutional limitations and the provisions of this Act, it is declared by Congress that, as a matter of national policy, foreign capital investments are welcome to the Philippines, provided—

(a) such investments will directly or indirectly contribute to the improvement of the international balance of payments;
