(The following is the text of the conference committee report on House Bill No. 1124.)

The Committee of Conference on the disagreeing votes of the two Houses on the amendment of the Senate to H. B. No. 1124, entitled:

AN ACT AMENDING SUB-PARAGRAPH SEVEN OF SECTION SEVENTEEN OF REPUBLIC ACT NUMBERED EIGHT HUNDRED SEVENTY-SEVEN, AS AMENDED BY REPUBLIC ACT NUMBERED FORTY-SEVEN HUNDRED AND FOUR, KNOWN AS THE PHILIPPINE NURSING LAW,

having met, after full and free conference have agreed to recommend and do recommend to their respective Houses as follows:

That H. B. No. 1124 be approved with the following amendments:

- 1) On line 4, between the words "orders" and "of", insert IN WRITING
- 2) On line 5, delete the comma (,) after the word "treatments" and insert AND
- 3) On same line, change the word "AND" to INCLUDING
- 4) On line 6, delete the comma (,) after the word "HYPODERMIC" and insert AND
- 5) On same line, delete the comma (,) after the word "INTRAMUSCULAR" and the following words: AND INTRAVENOUS
- 6) On line 7, delete the words "however, That" and in lieu thereof, add the following to read as follows:

THAT INTRAVENOUS AND OTHER INJECTIONS MAY BE ADMINISTERED UNDER THE DIRECTION AND IN THE PRESENCE OF A PHYSICIAN: PROVIDED, FURTHER, THAT THE PREVIOUS ORDER IN WRITING OF A PHYSICIAN SHALL NOT BE NECESSARY IF THE APPLICATION AND EXECUTION OF SUCH ORDER IS MADE IN THE PRESENCE OF SAID PHYSICIAN.

- 7) Make a new paragraph of lines 7 to 11 beginning with the word THIS of line 7 up to and including the word NURSING of line 11 to read as follows:

THIS SECTION SHALL NOT APPLY TO STUDENTS IN SCHOOLS AND COLLEGES OF NUR-

The PRESIDENT. With sixteen affirmative vote, no negative vote and no abstention, House Bill No. 1220 is approved on third reading.

Senator TOLENTINO. Mr. President, the conference committee on the disagreeing provisions of Senate Bill No. 551 and House Bill No. 1365 on the independence of the Supreme Court and other constitutional bodies has already submitted its report and that the report is that the House bill be approved containing the text of the Senate bill. The conference report is signed by the conferees on the part of the House and on the part of the Senate. (Pause) Mr. President, I would like to withdraw this.

The PRESIDENT. Withdrawn.
