#### BILLS ON FIRST READING

**The Secretary.** Senate Bill No. 793, entitled

AN ACT ESTABLISHING AN ECONOMIC AND FREE TRADE ZONE IN ZAMBOANGA CITY, CREATING THE ZAMBOANGA ECONOMIC AND FREE TRADE AUTHORITY, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.

Introduced by Senator Gonzales.

**The President.** Referred to the Committees on Economic Affairs; and Trade and Commerce.

**The Secretary.** Senate Bill No. 794, entitled

AN ACT PROVIDING FOR A COMPREHENSIVE AIR POLLUTION CONTROL POLICY, AND FOR OTHER PURPOSES.

Introduced by Senator Mercado.

**The President.** Referred to the Committee on Energy and Environment.

**The Secretary.** Senate Bill No. 795, entitled

AN ACT TO ABSOLUTELY PROHIBIT THE TRADE OR EXPORT OF WILDLIFE, BOTH FLORA AND FAUNA OR WHATEVER SPECIES, WHETHER DEAD OR ALIVE, PROVIDING PENALTY THEREFOR, AND FOR OTHER PURPOSES.

Introduced by Senator Mercado.

**The President.** Referred to the Committee on Natural Resources.

**The Secretary.** Senate Bill No. 796, entitled

AN ACT REQUIRING ALL REGISTRANTS OF ALL TYPES OF VEHICLES TO PLANT AT LEAST FIVE (5) TREES IN A PLACE TO BE DESIGNATED BY THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES IN CONSULTATION WITH THE LAND TRANSPORTATION OFFICE.

Introduced by Senator Mercado.

**The President.** Referred to the Committees on Public Services; and Natural Resources.

**The Secretary.** Senate Bill No. 797, entitled

AN ACT REQUIRING ALL PERSONNEL OF THE PHILIPPINE NATIONAL POLICE TO UNDERGO PSYCHIATRIC AND DRUG TESTS AND CREATING AN INTER-AGENCY PSYCHIATRIC AND DRUG EVALUATION COMMITTEE, AND APPROPRIATING FUNDS THEREFOR.

Introduced by Senator Webb.

**The President.** Referred to the Committees on National Defense and Security; and Local Government.

**The Secretary.** Senate Bill No. 798, entitled

AN ACT GRANTING TAX EXEMPTIONS TO FILIPINO WORKERS EARNING TWENTY THOUSAND DOLLARS (\$20,000) OR LESS REMITTED THROUGH THE PHILIPPINE BANKING SYSTEM.

Introduced by Senator Webb.

**The President.** Referred to the Committees on Ways and Means; and Labor, Employment and Human Resources Development.

**The Secretary.** Senate Bill No. 799, entitled

AN ACT ESTABLISHING A NATIONAL MAN-POWER AND YOUTH TRAINING CENTER IN EVERY CAPITAL TOWN AND CITY IN THE PHILIPPINES, AND APPROPRIATING FUNDS THEREFOR.

Introduced by Senator Webb.

**The President.** Referred to the Committees on Labor, Employment and Human Resources Development; and Local Government.

Senate Bill No. 132, providing for Retirement Pay to Qualified Private Sector Employees.

Also, we will take up the individual amendments, if there is still any, on Senate Bill No. 704, constituting the Legislative-Executive Development Council.

We will take up and consider Senate Bill No. 695, creating the Department of Energy. We are in the period of amendments on that bill.

We will take up also Senate Bill No. 556, authorizing the transfer of P5 billion from the Oil Price Stabilization Fund. We are still in the period of interpellations.

We will take up the sponsorship for Senate Bill No. 32, increasing fines and penalties for tax evasion, as well as Senate Bill No. 355, expanding the concept of the Condominium Act.

Finally, Mr. President, I move that we transfer to the Calendar for Special Orders, Senate Bill No. 176, on hazing as a crime, as reported out under Committee Report No. 18.
