PARLIAMENTARY INQUIRY OF SENATOR ROCO (On the Security Arrangements During the Impeachment Trial

Senator Roco. Again, a small point on this, Mr. President. There is a memorandum that we have received in our respective offices detailing how the security arrangements and how the pro or anti—I am not quite sure who they are referring to when they say "pro" or "anti". Pro what? Pro-Erap, Anti-Erap, Pro-Impeachment, Anti-Impeachment? The memorandum is not clear.

The President. Yes.

Senator Roco. In any event, Mr. President, for some reason, the Sergeant-at-Arms or whoever issued that memorandum restricted it to 1,000 people. It seems to me—as I remember the JBL rule and I am sure the Senate President is very familiar with the JBL rule—even if they were not given any permit as long as they keep walking, there is nothing that we can do about people who walk around this building as long as they use the pavement, the appropriate pedestrian lane. There is nothing in the Constitution that we can do. They do not even need permits. So I am wondering and I appreciate the need for security--what is the basis for this arbitrariness in allowing 1,000 people. Why not 20,000? Why not 20 people? How can we restrict when the Constitution is not suspended by the impeachment process?

So, I am just raising an attention to this, Mr. President. Maybe we can address that in caucus, but it is serious to me what we may be establishing as precedence.

The President. All right. So we will take that up after the session then, Senator Roco.

Senator Roco. In a caucus? So are we having a caucus afterwards?

The President. Afterwards.

Senator Roco. Thank you, Mr. President.

The President. The Majority Leader is recognized.

Senator Tatad. May Inow reiterate my motion, Mr. President.

Senator Cayetano. Mr. President.

The President. Sen. Renato L. Compañero Cayetano is recognized.

REMARKS OF SENATOR CAYETANO (On Assurance of Security of the Senate)

Senator Cayetano. Mr. President, before that, I just want to add my voice to what Senator Roco said. Unfortunately, I could

not attend the session because of an important personal matter which would require my presence—I mean the caucus. My daughter is in the hospital. But I would like to be assured that we do reconsider in the caucus the possibility, in fact, of getting as many as the space will provide as long as the security of the Senate is well-secured in order not to jeopardize not only the members of the Senate but also our visitors. I would just like to express that because I could not attend the caucus.

Thank you, Mr. President.

The President. The Chair thanks Senator Cayetano. His views will certainly be taken into account.

Shall we now recognize Sen. Tessie Aquino-Oreta?

Senator Tatad. Mr. President, we are now discussing Senate Bill No. 2113. We are still in the period of interpellations. Two senators have made reservation to interpellate but I am informed that they have since withdrawn their reservations, may I ask the sponsor to kindly confirm this for the record.

Senator Aquino-Oreta. Yes, Mr. President. I was waiting for Senator Defensor Santiago and we asked her if she still wanted to interpellate on this Philippine Science High School System and she said she would forego her interpellation.

The President. All right.

Senator Tatad. How about the second reservation?

Senator Aquino-Oreta. Senator Revilla also said that he would forego his interpellation on this bill.

Senator Tatad. In which case, Mr. President, we can move ahead. I move that the period of interpellations on this bill be closed.

The President. Is there any objection? [Silence] There being none, the period of interpellations is closed.

Senator Tatad. I move that we now consider the committee amendments.

The President. Are there any committee amendments?

COMMITTEE AMENDMENTS

Senator Aquino-Oreta. Thank you, Mr. President. Before I go to my committee amendments, I would just like to put on record that Committee Report No. 383 already includes House Bill No. 11651.

And so for the committee amendments, Mr. President, they are only some words for correction. On page 4, line 22, the word "bequest" be...

The President. Page 4, line 22. All right. The word "bequest"?

Senator Aquino-Oreta. Yes, Mr. President, we will make it plural, bequests.

The President. Pardon?

Senator Aquino-Oreta. We will just add the letter S on the word "bequest". So, it has to be plural, bequests.

The President. All right.

Senator Aquino-Oreta. Under ...

The President. May we take it up now for approval?

Is there any objection to that amendment? [Silence] There being none, the amendment is approved.

Senator Aquino-Oreta. On the same page, Mr. President, in line 25, the word "function" is again plural, FUNCTIONS.

The President. All right. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Aquino-Oreta. Again, Mr. President, on the same page, line 27, delete the word "gain" and replace it with the word DONOR.

The President. What is the word again, please?

Senator Aquino-Oreta. Delete the word "gain" and replace it with the word DONOR.

The President. DONOR.

Senator Aquino-Oreta. Yes, Mr. President. And so...

The President. Is there any objection to the motion? [Silence] There being none, the amendment is approved.

Senator Aquino-Oreta. That is all for the committee amendments, Mr. President.

The President. Shall we close the period of committee amendments?

Senator Tatad. I move that we close the period of committee amendments.

The President. Is there any objection? [Silence] There being none, the motion is approved.

Senator Tatad. The sponsor is now ready to receive the individual amendments, if any.

The President. Are there any individual amendments?

Senator Tatad. There is no indication of ...

Senator Flavier. Mr. President.

The President. Senator Flavier is recognized.

Senator Flavier. Mr. President, on page 4 line 1.

The President. On page 4, line 1, all right.

Senator Flavier. Delete the phrase "fix the site of the" and in its place, insert the words ESTABLISHA. So that line 1 will read, thus: "ESTABLISH A PSHS campus in each of the administrative regions;".

The President. Is the individual amendment acceptable to the sponsor?

Senator Aquino-Oreta. It is accepted, Mr. President.

The President. Is there any objection? [Silence] There being none, the amendment is approved.

Senator Tatad. Mr. President, there are no further individual amendments. I move that the period of individual amendments be closed.

The President. There is a motion to close the period of individual amendments. Is there any objection? [Silence] There being none, the motion is approved.

Senator Tatad. I move that we vote on Second Reading on Senate Bill No. 2113.

BILL ON SECOND READING S. No. 2048 – The AFP Tax Exemption for Pay and Allowances Act of 2000 (Continuation)

Senator Tatad. Mr. President, I move that we resume consideration of Senate Bill No. 2048 as reported out under Committee Report No. 360.

The President. Is there any objection? [Silence] There being none, resumption of consideration of Senate Bill No. 2048 is now in order. Whom do we recognize here?

Senator Tatad. Mr. President, this is the tax exemption bill for members of the Armed Forces of the Philippines. We are still in the period of interpellations. I ask that the sponsor, Sen. Juan Ponce Enrile, be recognized, and for the interpellation, Sen. Franklin M. Drilon.

The President. Sen. Juan Ponce Enrile is recognized, and Sen. Franklin M. Drilon to interpellate.

Senator Drilon. Thank you, Mr. President.

Before anything else, we wish to manifest for the record that we are supportive of this bill under consideration, Senate Bill No. 2048. In fact, this representation is listed as a coauthor of this measure, and we thank the sponsor for including us as a coauthor. Indeed, Mr. President, every possible assistance to our government workers not only to our soldiers is most welcome at this time. Indeed, this is one of the measures which can help our soldiers. It is in that context that I ask the sponsor to yield the floor for a few questions.

Senator Enrile. Gladly, Mr. President.

Senator Drilon. Mr. President, may we know if the exemption sought to be granted under the bill for the armed forces personnel is also being granted to our police personnel?

Senator Enrile. The police personnel are now enjoying this tax exemption, Mr. President.

Senator Drilon. So the purpose of the bill is to equate the income tax treatment between the police and the armed forces?

Senator Enrile. That is correct, Mr. President.

Senator Drilon. Would the incomes enumerated in Section 3 of this measure or the income enumerated here be the same income that the PNP would receive, Mr. President?

Senator Enrile. I do not know whether they are the same, but more or less, I think, with some differences because of the nature of the work of the members of the two organizations.

Senator Drilon. Mr. President, for example, would the PNP personnel have a longevity pay and would they be exempted from income taxation?
