This has been crafted out of the bill with the special help from the Majority Leader. So, at least, that area of concern has been relieved, Mr. President.

We vote yes therefore for this with the caution to PRC that even as it now starts grading the universities and colleges based on the test results, it should also exert every effort to ensure fairness and the level application of the law. We have every expectation, Mr. President, that that will be done.
