I was hoping I would be able to support this bill, but on deeper analysis, I have my very serious doubts that there should be a law that would punish persons below 18 years of age with fine of P20,000 or imprisonment for 60 days. So, I regret I will have to abstain.

#### EXPLANATION OF VOTE OF SENATOR WEBB

Senator Webb. May I explain my vote, Mr. President.

Scientific and technological innovations bring about use and disuse. Take for example, calculators. While they make it easy for accountants, housewives and others to make calculations, such contraptions have encouraged pupils and students to forego mental exercise in favor of the more convenient finger exercise of pushing buttons or keys to get the correct answer.

Another example is television, Mr. President. While it has brought easy access to worldwide information, it has made a lot of people passive watchers or listeners, even easy believers. Television is not called an idiot box for nothing.

While personal computers have brought about possibilities unheard of before, like composing poetry and making speeches at the push of a key, they could make human minds atrophy for lack of use. While I wholly support and hope for more scientific and technological innovations, I humbly submit that we should go back to the time proven fundamental methods of training young minds. The three R's may no longer be in vogue in this era of sophisticated gadgetry. But they still are necessary if we are to make our future citizens great minds and greater leaders.

For this reason, I fully support Senate Bill No. 925, which seeks to establish Municipal Libraries and Barangay Reading Centers for it clearly intends to improve the reading habits of Filipinos, especially the young, by providing them with accessible reading materials and consequently expand their intellectual horizon.

I am voting Yes to Senate Bill No. 925.
